Implementation of the international drug control treaties: other matters arising from the international drug control treaties

Burkina Faso, Côte d'Ivoire, Morocco, Niger and Sudan: revised draft resolution

Responding to the threat posed by the distribution of medicines, including counterfeit medicines, on the unregulated market

The Commission on Narcotic Drugs,

Considering that the illicit distribution of medicines, including medicines containing internationally controlled substances, on the unregulated market continues to be a serious problem in many countries, in particular in developing countries,

Noting that the International Narcotics Control Board, in its report for 2006,¹ highlighted, inter alia, the problems relating to internationally controlled drugs and the unregulated market,

Considering that some medicines containing internationally controlled substances are diverted from the legitimate, official market and are sold on the unregulated market or are counterfeit medicines,

Noting that such counterfeit medicines, containing internationally controlled substances are of substandard quality or ineffective and that their use may have harmful or even fatal health consequences and can lead to dependence on drugs,

Noting also that medicines diverted from legitimate markets may be modified and thus harmful to health,

Recalling the current extent of the problem of the distribution of medicines on the unregulated market, which is increasingly characterized by smuggling networks

operating in an organized and structured illicit market and by the expansion of the range of products containing narcotic drugs or psychotropic substances available on that market,

Noting that the consumption of medicines sold on the unregulated market is linked primarily to poverty and economic stagnation in developing countries,

Being aware that many States affected by the illicit distribution of medicines and the deleterious use of medicines obtained on the unregulated market have taken a number of prevention and control measures to combat that global scourge,

Noting the efforts made by international organizations such as the World Health Organization, the World Customs Organization and the International Criminal Police Organization (Interpol) and by relevant regional organizations to combat the problem more effectively and to protect populations,

- 1. Requests partner States to continue to offer to affected States their full cooperation and support through the provision of human and material resources, including the organization of training programmes;
- 2. Encourages States affected by the scourge of the distribution of medicines, including counterfeit medicines, on the unregulated market to consider adopting measures to enable the swift detection of new forms of illicit distribution of medicines, including those containing internationally controlled substances, and the use of medicines obtained on the unregulated market;
- 3. Requests Member States to give consideration to implementing the recommendations of the International Narcotics Control Board as set out in its annual report for 2006,² in particular with a view to:
- (a) Strictly applying the provisions of the international drug control treaties to prevent internationally controlled substances from being diverted to the unregulated market;
- (b) Implementing effective policies to combat the manufacturing and distribution of counterfeit medicines;
- (c) Providing a comprehensive legal framework to make trading in counterfeit products a serious criminal offence;
- (d) Ensuring that the States concerned take all applicable legislative and regulatory measures to prevent the export of products that are counterfeit or of poor quality;
- 4. Requests the United Nations Office on Drugs and Crime, in cooperation with the World Health Organization, the World Customs Organization and the International Criminal Police Organization (Interpol), to assist Member States in combating the illicit distribution and use of medicines, including counterfeit medicines, containing internationally controlled substances.
