Summary statement by the Secretary-General on matters of which the Security Council is seized and on the stage reached in their consideration

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, and in accordance with paragraph 7 of the note by the President dated 19 December 2007 (S/2007/749), the Secretary-General is submitting the following summary statement.

The complete list of items of which the Security Council was seized as at 2 February 2008 is contained in document S/2008/10/Add.4 of 7 February 2008.

The present addendum lists the items on which the Security Council took action during the week ending 23 February 2008. The dates given for each item indicate when the item was first taken up by the Council at a formal meeting, and the most recent formal meeting of the Council held on that item.

Security Council resolutions 1160 (1998), 1199 (1998), 1203 (1998), 1239 (1999) and 1244 (1999) (5 November 1999; 18 February 2008)

The Security Council resumed its consideration of the item at its 5839th meeting, held on 18 February 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representative of Serbia, at his request, to participate in the consideration of the item without the right to vote.

Reports of the Secretary-General on the Sudan (11 June 2004; 19 February 2008)

The Security Council resumed its consideration of the item at its 5840th meeting, held on 19 February 2008. Under rule 39 of its provisional rules of procedure, the Council extended an invitation to Ashraf Jehangir Qazi, Special Representative of the Secretary-General for the Sudan.

International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (8 May 1996; 20 February 2008)

The Security Council resumed its consideration of the item at its 5841st meeting, held on 20 February 2008. The Council proceeded to vote on draft resolution S/2008/107, which had been prepared in the course of the Council's prior consultations, and adopted it unanimously as resolution 1800 (2008).



The situation in Somalia (17 March 1992; 20 February 2008)

The Security Council resumed its consideration of the item at its 5842nd meeting, held on 20 February 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representative of Somalia, at his request, to participate in the consideration of the item without the right to vote. The Council proceeded to vote on draft resolution S/2008/113, submitted by the United Kingdom of Great Britain and Northern Ireland, and adopted it unanimously as resolution 1801 (2008).

The situation in Timor-Leste (15 December 1975; 21 February 2008)

The Security Council resumed its consideration of the item at its 5843rd meeting, held on 21 February 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representatives of Australia, Brazil, Japan, New Zealand, the Philippines, Portugal, Slovenia and Timor-Leste, at their request, to participate in the consideration of the item without the right to vote. Under rule 39 of its provisional rules of procedure, the Council extended an invitation to Jean-Marie Guéhenno, Under-Secretary-General for Peacekeeping Operations.
