## Financing of the United Nations Mission for the Referendum in Western Sahara

## **Report of the Fifth Committee**

Rapporteur: Mr. Steven Ssenabulya Nkayivu (Uganda)

## I. Introduction

1. At its 3rd plenary meeting, on 21 September 2007, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-second session the item entitled "Financing of the United Nations Mission for the Referendum in Western Sahara" and to allocate it to the Fifth Committee.

2. The Fifth Committee considered the item at its 40th and 51st meetings, on 12 May and 13 June 2008. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary records (A/C.5/62/SR.40 and 51).

3. For its consideration of the item, the Committee had before it the following documents:

(a) Report of the Secretary-General on the financial performance of the United Nations Mission for the Referendum in Western Sahara for the period from 1 July 2006 to 30 June 2007 (A/62/611);

(b) Report of the Secretary-General on the budget for the United Nations Mission for the Referendum in Western Sahara for the period from 1 July 2008 to 30 June 2009 (A/62/679);

(c) Related report of the Advisory Committee on Administrative and Budgetary Questions (A/62/781/Add.3);

(d) The note by the Secretary-General on the financing arrangements for the United Nations Mission for the Referendum in Western Sahara for the period from 1 July 2007 to 30 June 2008 (A/62/817).



## II. Consideration of draft resolution A/C.5/62/L.42

4. At its 51st meeting, on 13 June, the Committee had before it a draft resolution entitled "Financing of the United Nations Mission for the Referendum in Western Sahara" (A/C.5/62/L.42), submitted by the representative of Uganda and Rapporteur of the Committee following the informal consultations.

5. Before the consideration of the draft resolution, the Secretary of the Committee orally corrected the text as follows:

(a) In operative paragraph 1, after the date "30 June 2006", the word "and" was added and the phrase "and 62/\_\_\_\_ of \_\_\_\_\_" was deleted;

(b) In operative paragraph 12, after the figure "60/266", the word "and" was added and the phrase "and 62/\_\_\_\_" was deleted.

6. At the same meeting, the Committee adopted draft resolution A/C.5/62/L.42, as orally corrected, without a vote (see para. 7).

### **III.** Recommendation of the Fifth Committee

7. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolution:

# Financing of the United Nations Mission for the Referendum in Western Sahara

#### The General Assembly,

*Having considered* the reports of the Secretary-General on the financing of the United Nations Mission for the Referendum in Western Sahara,<sup>1</sup> the related report of the Advisory Committee on Administrative and Budgetary Questions,<sup>2</sup> the note by the Secretary-General on the financing arrangements for the Mission,<sup>3</sup> and the oral statement made by the Chairman of the Advisory Committee on Administrative and Budgetary Questions,<sup>4</sup>

*Recalling* Security Council resolution 690 (1991) of 29 April 1991, by which the Council established the United Nations Mission for the Referendum in Western Sahara, and the subsequent resolutions by which the Council extended the mandate of the Mission, the latest of which was resolution 1813 (2008) of 30 April 2008, by which the Security Council extended the mandate of the Mission until 30 April 2009,

*Recalling also* its resolution 45/266 of 17 May 1991 on the financing of the Mission and its subsequent resolutions and decisions thereon, the latest of which was resolution 61/290 of 29 June 2007,

*Reaffirming* the general principles underlying the financing of United Nations peacekeeping operations, as stated in General Assembly resolutions 1874 (S-IV) of 27 June 1963, 3101 (XXVIII) of 11 December 1973 and 55/235 of 23 December 2000,

*Noting with appreciation* that voluntary contributions have been made to the Mission,

*Mindful* of the fact that it is essential to provide the Mission with the financial resources necessary to enable it to fulfil its responsibilities under the relevant resolutions of the Security Council,

1. *Reiterates its request* to the Secretary-General to entrust the Head of Mission with the task of formulating future budget proposals in full accordance with the provisions of General Assembly resolutions 59/296 of 22 June 2005, 60/266 of 30 June 2006 and 61/276 of 29 June 2007, as well as other relevant resolutions;

2. *Takes note* of the status of contributions to the United Nations Mission for the Referendum in Western Sahara as at 31 March 2008, including the contributions outstanding in the amount of 46.8 million United States dollars, representing some 7 per cent of the total assessed contributions, notes with concern

that only sixty-eight Member States have paid their assessed contributions in full, and urges all other Member States, in particular those in arrears, to ensure payment of their outstanding assessed contributions;

3. *Expresses its appreciation* to those Member States which have paid their assessed contributions in full, and urges all other Member States to make every possible effort to ensure payment of their assessed contributions to the Mission in full;

4. *Expresses concern* at the financial situation with regard to peacekeeping activities, in particular as regards the reimbursements to troop contributors that bear additional burdens owing to overdue payments by Member States of their assessments;

5. Also expresses concern at the delay experienced by the Secretary-General in deploying and providing adequate resources to some recent peacekeeping missions, in particular those in Africa;

6. *Emphasizes* that all future and existing peacekeeping missions shall be given equal and non-discriminatory treatment in respect of financial and administrative arrangements;

7. Also emphasizes that all peacekeeping missions shall be provided with adequate resources for the effective and efficient discharge of their respective mandates;

8. *Reiterates its request* to the Secretary-General to make the fullest possible use of facilities and equipment at the United Nations Logistics Base at Brindisi, Italy, in order to minimize the costs of procurement for the Mission;

9. *Endorses* the conclusions and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions,<sup>2</sup> and in the oral statement made by the Chairman of the Advisory Committee on Administrative and Budgetary Questions,<sup>4</sup> subject to the provisions of the present resolution, and requests the Secretary-General to ensure their full implementation;

10. Decides not to approve the Field Service post in the Archiving Unit;

11. *Also decides* to provide general temporary assistance for the national General Service post in the Archiving Unit for one year, and requests the Secretary-General to rejustify its continuation in the context of the next budget submission;

12. *Requests* the Secretary-General to ensure the full implementation of the relevant provisions of its resolutions 59/296, 60/266 and 61/276;

13. *Also requests* the Secretary-General to take all necessary action to ensure that the Mission is administered with a maximum of efficiency and economy;

14. *Further requests* the Secretary-General, in order to reduce the cost of employing General Service staff, to continue efforts to recruit local staff for the Mission against General Service posts, commensurate with the requirements of the Mission;

#### Financial performance report for the period from 1 July 2006 to 30 June 2007

15. *Takes note* of the report of the Secretary-General on the financial performance of the Mission for the period from 1 July 2006 to 30 June 2007;<sup>5</sup>

#### Financing arrangements for the period from 1 July 2007 to 30 June 2008

16. *Also takes note* of the note by the Secretary-General on the financing arrangements for the Mission for the period from 1 July 2007 to 30 June 2008;<sup>3</sup>

17. *Decides* to appropriate to the Special Account for the United Nations Mission for the Referendum in Western Sahara the amount of 1,754,200 dollars for the maintenance of the Mission for the period from 1 July 2007 to 30 June 2008, in addition to the amount of 46,471,700 dollars already appropriated for the Mission for the same period under the terms of General Assembly resolution 61/290;

## Financing of the additional appropriation for the period from 1 July 2007 to 30 June 2008

18. Also decides, taking into account the amount of 46,471,700 dollars already apportioned under the terms of General Assembly resolution 61/290, to apportion among Member States the additional amount of 1,754,200 dollars for the maintenance of the Mission for the period from 1 July 2007 to 30 June 2008, in accordance with the levels updated in its resolution 61/243 of 22 December 2006, and taking into account the scale of assessments for 2007 and 2008, as set out in its resolution 61/237 of 22 December 2006;

19. *Further decides* that, in accordance with the provisions of its resolution 973 (X) of 15 December 1955, the decrease of 235,000 dollars in the estimated staff assessment income in respect of the financial period from 1 July 2007 to 30 June 2008 shall be added to the apportionment among Member States as provided for in paragraph 18 above;

#### Budget estimates for the period from 1 July 2008 to 30 June 2009

20. *Decides* to appropriate to the Special Account for the United Nations Mission for the Referendum in Western Sahara the amount of 47,702,500 dollars for the period from 1 July 2008 to 30 June 2009, inclusive of 45,600,800 dollars for the maintenance of the Mission, 1,832,100 dollars for the support account for peacekeeping operations and 269,600 dollars for the United Nations Logistics Base;

#### Financing of the appropriation for the period from 1 July 2008 to 30 June 2009

21. Also decides to apportion among Member States the amount of 39,752,080 dollars for the period from 1 July 2008 to 30 April 2009, in accordance with the levels updated in General Assembly resolution 61/243, and taking into account the scale of assessments for 2008 and 2009, as set out in its resolution 61/237;

22. Further decides that, in accordance with the provisions of its resolution 973 (X), there shall be set off against the apportionment among Member States, as provided for in paragraph 21 above, their respective share in the Tax

Equalization Fund of 1,909,500 dollars, comprising the estimated staff assessment income of 1,745,080 dollars approved for the Mission, the prorated share of 146,670 dollars of the estimated staff assessment income approved for the support account and the prorated share of 17,750 dollars of the estimated staff assessment income approved for the United Nations Logistics Base;

23. *Decides* to apportion among Member States the amount of 7,950,420 dollars for the period from 1 May to 30 June 2009, at a monthly rate of 3,975,208 dollars, in accordance with the levels updated in General Assembly resolution 61/243, and taking into account the scale of assessments for 2009 as set out in General Assembly resolution 61/237, subject to a decision of the Security Council to extend the mandate of the Mission;

24. Also decides that, in accordance with the provisions of its resolution 973 (X), there shall be set off against the apportionment among Member States, as provided for in paragraph 23 above, their respective share in the Tax Equalization Fund of 381,900 dollars, comprising the estimated staff assessment income of 349,020 dollars approved for the Mission, the prorated share of 29,330 dollars of the estimated staff assessment income approved for the support account and the prorated share of 3,550 dollars of the estimated staff assessment income approved for the United Nations Logistics Base;

25. Further decides that, for Member States that have fulfilled their financial obligations to the Mission, there shall be set off against their apportionment, as provided for in paragraph 21 above, their respective share of the unencumbered balance and other income in the total amount of 2,903,700 dollars in respect of the financial period ended 30 June 2007, in accordance with the levels updated in General Assembly resolution 61/243, taking into account the scale of assessments for 2007, as set out in its resolution 61/237;

26. *Decides* that, for Member States that have not fulfilled their financial obligations to the Mission, there shall be set off against their outstanding obligations their respective share of the unencumbered balance and other income in the total amount of 2,903,700 dollars in respect of the financial period ended 30 June 2007, in accordance with the scheme set out in paragraph 25 above;

27. Also decides that the decrease of 345,700 dollars in the estimated staff assessment income in respect of the financial period ended 30 June 2007 shall be set off against the credits from the amount of 2,903,700 referred to in paragraphs 25 and 26 above;

28. *Emphasizes* that no peacekeeping mission shall be financed by borrowing funds from other active peacekeeping missions;

29. *Encourages* the Secretary-General to continue to take additional measures to ensure the safety and security of all personnel participating in the Mission under the auspices of the United Nations, bearing in mind paragraphs 5 and 6 of Security Council resolution 1502 (2003) of 26 August 2003;

30. *Invites* voluntary contributions to the Mission in cash and in the form of services and supplies acceptable to the Secretary-General, to be administered, as appropriate, in accordance with the procedure and practices established by the General Assembly;

31. *Decides* to include in the provisional agenda of its sixty-third session the item entitled "Financing of the United Nations Mission for the Referendum in Western Sahara".
