## CABLE DATED 14 FEBRUARY 1961 FROM THE SECRETARY OF STATE FOR THE PRESIDENCY AND NATIONAL DEFENCE OF THE TUNISIAN GOVERNMENT ADDRESSED TO THE SECRETARY-GENERAL

I AM INSTRUCTED BY MR. HABIB BOURGUIBA, PRESIDENT OF THE TUNISIAN REFUBLIC, TO TRANSMIT THE FOLLOWING MESSAGE TO YOU.

ACCORDING TO NEWS BROADCAST IN ELIZABETHVILLE ON THE AFTERNOON OF 13 FEBRUARY 1961 MR. PATRICE LUMUMBA, MR. MAURICE MPOLO AND MR. JOSEPH OKITO WERE KILLED THE PREVIOUS DAY IN A VILLAGE IN KATANGA. THIS NEWS HAS AROUSED MY DEEP INDIGNATION AND IS LIKELY TO HAVE SERIOUS REPERCUSSIONS IN THE CONGO AND ELSEWHERE. THE STORY OF THE ESCAPE OF MR. LUMUMBA AND HIS FELLOW PRISONERS REALLY COVERS AN ODIOUS CRIME PERPETRATED BY THE KATANGAN AUTHORITIES IN ORDER TO RID THEMSELVES OF THEIR POLITICAL ADVERSARIES. I RECENTLY HAD OCCASION TO BRING TO YOUR ATTENTION THE BRUTALITIES INFLICTED ON MR. LUMUMBA DURING HIS TRANSFER TO KATANGA AND THE BEHAVIOUR, SUPRISING TO SAY THE LEAST, OF THE CENTRAL CONGOLESE GOVERNMENT IN AGREEING TO HAND OVER MR. LUMUMBA TO MOISHE TSHOMBE, HIS AVOWED ENEMY. THE PHYSICAL ELIMINATION OF MR. LUMUMBA AND HIS COMPANIONS POINTS UP THE CONTEMPT PROFESSED BY CERTAIN CONGOLESE LEADERS FOR THE SACRED AND FUNDAMENTAL PRINCIPLES OF ALL STATES WORTHY OF THE NAME. IT REVEALS A DANGEROUS PERSISTENCE IN UNDERMINING THE CHANCES OF A PEACEFUL SOLUTION OF THE CONGO PROBLEM AND IN DEFYING THE EFFORTS UNDERTAKEN TO THAT END BY NATIONS OF GOOD WILL. I AM SURE THAT THE UNITED NATIONS WILL STRONGLY CONDEMN SUCE EXCESSES. I WISH TO ASSURE YOU THAT MY GOVERNMENT IS PREFARED AT ALL TIMES TO SUPPORT THE UNITED NATIONS IN ITS EFFORTS TO CALM PASSIONS AND RESTORE PEACE AND LEGALITY.
