### II. ANNOTATIONS TO THE PROVISIONAL AGENDA

### Opening

1. The provisional agenda and timetable for the fourteenth session of the United Nations Centre for Trade Facilitation and Electronic Business (UN/CEFACT) have been drawn up by the secretariat in consultation with the Chair and the Bureau on the basis of the decisions and programme of work adopted by the Centre at its thirteenth session. On Monday, 15 September as of 15:30, informal organized consultations between delegates from national capitals, country diplomatic missions based in Geneva and UN/CEFACT office holders will take place. On Tuesday, 16 September beginning at 10:00, there will be an introductory overview of UN/CEFACT and a discussion of any issues identified during the consultations that took place on Monday 15. Interpretation will be available during both of these informal sessions. The formal session will begin on Tuesday at 14:30. On Wednesday, 17 September in the afternoon, after the discussion on the programme of work and the election of officers, the Centre will approve the decisions of the fourteenth session.

2. The session will be opened by the Executive Secretary of the United Nations Economic Commission for Europe (UNECE).
