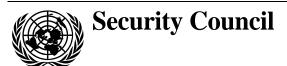

# Summary statement by the Secretary-General on matters of which the Security Council is seized and on the stage reached in their consideration

#### Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to submit the list of items of which the Security Council is currently seized. The last full list of items (S/2008/10/Add.13) was issued on 9 April 2008. The last weekly addendum (S/2008/10/Add.16) covered developments up to 26 April 2008.

As the present addendum is the first to be issued in May 2008, it contains a full, updated list of items of which the Security Council is seized, indicating the date on which each item was first taken up by the Council at a formal meeting, and the date of the most recent formal Council meeting held on that item.<sup>1</sup>

## The situation concerning Iraq (31 May 2005; 28 April 2008)

The Security Council resumed its consideration of the item at its 5878th meeting, held on 28 April 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representative of Iraq, at his request, to participate in the consideration of the item without the right to vote. Under rule 39 of its provisional rules of procedure, the Council extended an invitation to B. Lynn Pascoe, Under-Secretary-General for Political Affairs.

## The situation in Somalia (17 March 1992; 29 April 2008)

The Security Council resumed its consideration of the item at its 5879th meeting, held on 29 April 2008. The Council, under rule 37 of its provisional rules

of procedure, invited the representative of Somalia, at his request, to participate in the consideration of the item without the right to vote. The Council proceeded to vote on draft resolution S/2008/278, submitted by the United Kingdom of Great Britain and Northern Ireland, and adopted it unanimously as resolution 1811 (2008).

## The situation in Côte d'Ivoire (20 December 2002; 29 April 2008)

The Security Council resumed its consideration of the item at its 5880th meeting, held on 29 April 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representative of Côte d'Ivoire, at his request, to participate in the consideration of the item without the right to vote. The President, on behalf of the Council, made a statement (S/PRST/2008/11).

#### **Small arms** (24 September 1999; 30 April 2008)

The Security Council resumed its consideration of the item at its 5881st meeting, held on 30 April 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representatives of Australia, Austria, Argentina, Benin, Brazil, Canada, Chile, Colombia, the Congo, Ecuador, Guatemala, Honduras, Iceland, Israel, Jamaica, Japan, Kazakhstan, Kenya, Lesotho, Liechtenstein, Malawi, Mexico, the Netherlands, Nigeria, Peru, the Philippines, Slovenia, Sri Lanka, Switzerland, the Syrian Arab Republic, Uganda and Uruguay, at their request, to participate in the consideration of the item without the right to vote. Under rule 39 of its provisional rules of procedure, the Council extended an invitation to Hannelore Hoppe, Director and Deputy to the High Representative for Disarmament Affairs.

## Reports of the Secretary-General on the Sudan (11 June 2004; 30 April 2008)

The Security Council resumed its consideration of the item at its 5882nd meeting, held on 30 April 2008. The Council proceeded to vote on draft resolution S/2008/283, submitted by Belgium, Costa Rica, Croatia, France, Italy, the United Kingdom of Great Britain and Northern Ireland and the United States of America, and adopted it unanimously as resolution 1812 (2008).

## The situation between Eritrea and Ethiopia (26 June 1998; 30 April 2008)

The Security Council resumed its consideration of the item at its 5883rd meeting, held on 30 April 2008. The President, on behalf of the Council, made a statement (S/PRST/2008/12).

## The situation concerning Western Sahara (20 October 1975; 30 April 2008)

The Security Council resumed its consideration of the item at its 5884th meeting, held on 30 April 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representative of Spain, at his request, to participate in the consideration of the item without the right to vote. The Council proceeded to vote on draft resolution S/2008/284, submitted by France, the Russian Federation, Spain, the United Kingdom of Great Britain and Northern Ireland and the United States of America, and adopted it unanimously as resolution 1813 (2008).
