COLOV, Ernest S. B.

Born 1891; Graduated in Law 1915.

Judge of the Supreme Court of Justice.

Assistant Head of Section in Soro County, 1915; Secretary in the Ministry of Justice, 1916; Acting Judge in the Copenhagen Town Court, 1923-25; Head of section, Ministry of Justice, 1933; Judge of the High Court of the Eastern Division, 1939; Judge of Supreme Court of Justice, 1944; President of the Ministry of Justice's Traffic Board of 1935 and of the Appeal Board concerning Import Allocation Cases, 1945; President and member of various other committees.

Knight of the Royal Order of Dannebrog and decorated with the Silver Cross of the same order.

DIHIGO, Ernesto

Born, 1896, in Cuba; graduated as Bachelor in Science and Letters, 1912; received the degrees of Doctor of Civil Law, 1917, and Doctor of Philosophy and Letters, 1918.

Professor of Roman Law in the Faculty of Law in the University of Havana since 1917; Dean of the Law School from 1939 to 1942; Professor of Commercial Law, School of Commercial Science, since 1934; Member of the Superior Electoral Tribunal, 1934, and of the Official Committee on public works expenditure in 1934; Member of the Havana bar and of the National Academy of Arts and Letters; former Minister of Foreign Affairs of Cuba; Cuban delegate to the Chapultepec Conference, Mexico, 1945, and to the United Nations Conference on International Organization, San Francisco, 1945; Delegate to the Second Session of the General Assembly of the United Nations, 1947.

Recipient of the gold medal of the Assembly of the Colegio de Abogados in . Havana, 1932.

Recieved Grand Cross of the Order of Dannebrog and of the (Swedish) Order of the North Star.

#### KARDAHI, Choucri

Born, Beirut, Lebanon - 1890; studied Law at the University of Aix-Marseilles and the Faculty of Paris; received degree of Dr. honoris causa from the University of Algiers, 1944. Practiced in the Egyptian Mixed Courts 1911-1920. Professor at the French School of Law, Beirut, 1920; Counsellor to the Court of Cassation 1922; First President of the Court of Cassation, 1934; Minister of Justice, 1927 and 1928; Member of the Law Academy of Toulouse and of the Board of the Comparative Law Association of Paris; Correspondent of the Committee of Jurists on Foreign Legislation and International Law set up by the French Ministry of Justice, 1935; lectured at the Academy of International Law at The Hague in 1935 and 1937; Member of the Executive Council of the World Federation of International Juridical Institutions, Paris; Author of "Conflicts of Laws in Islam and Their Development", a two-volume work to be published in the near future; One of the principal contributors to the revue critique de droit international privé, Paris.

#### de LAVALLE, Juan Bautista

Born, 1887, in Peru.

Awarded the degrees of Doctor of Laws and Doctor of Philosophy by the University of San Marcos, Peru; attended the courses given in the Faculty of Law in the University of Paris.

Appointed Executive-Secretary in Peru with the American Association for the International Counciliation of the Carnegie Foundation for International Peace, 1913. Secretary and Chargé d'Affaires in Bolivia 1916-1918; First Secretary of the Peruvian Legation in France where he also acted as Secretary of the Peruvian Delegation to the Peace Conference 1919-1920. Judge on the Superior Court in Lima 1930; Alternate Justice on the Supreme Court of Justice 1938; elected as Justice by the Congress of Peru 1945; appointed to the First Council of the Inter-American Bar Association, 1941, and served in the same capacity at the Second Conference of the Inter-American Bar Association, 1943; Member of the Special Committee which drafted a revision of the Commercial Code of Peru 1942-1944; Delegate Plenipotentiary to the Eighth and Ninth International Conference of American States held in Peru, 1938, and Colombia, 1948, respectively; Peruvian representative to the Inter-American Conference of Experts on Copyright held in Washington, 1946; Ambassador Representative of Peru on the Council of the Organization of American States since 1946, holding the Office of Chairman of the Council for the period 1947-1948 Chairman of the Peruvian Delegation to the First Special Session of the United Nations General Assembly; Peruvian Delegate to the Second Part of the First Session of the General Assembly, 1946, and to the Second, Fourth, Fifth and Seventh Sessions of the General Assembly; as a member of the Peruvian Delegation, he took part in the meeting of Consultation of Ministers of Foreign Affairs of American States held in Washington, 1951.

Member of the Peruvian Academic Faculty with the Royal Spanish Academy of Languages; Former Member of the Peruvian Society of International Law, of the Peruvian Committee of the Society of Comparative Law of Paris; Honorary Member of the Brazilian Bar Association; Patron of the International Bar Association; Honorary Member of the Pan-American Society of the United States in New York;

Member of the Institute of Legislative Studies in Rome, of the Argentine Institute of Legal and Social Philosophy, of the American Forum of Washington, (Ateneo Americano); and of the Advisory Committee of American States of the American University of Washington.

# LOPEZ PINEDA, Julián

Born, 1882, in Honduras; received the degree of Bachelor of Science and Letters from the National Institute for Men at Tegucigalpa, and the degree of Doctor of Jurispurdence in Political and Social Science from the Faculty of El Salvador, 1905; obtained later a law degree in Honduras.

Frofessor in the Faculty of Law at Honduras; Private Secretary to the President of the Republic, 1902; Charge d'Affaires, later chief of the diplomatic mission of Honduras in France; permanent delegate of Honduras to the League of Nations; envoy extraordinary and minister plenipotentiary to the Government of Nicaragua; representative with plenipotentiary powers at the Inter-America Conference for the Maintenance of Peace, held in Argentina; head of the Honduras delegation to the Eighth International Conference of American States, held in Peru; representative of Honduras with plenipotentiary powers at the mediation conferences held in Costa Rica on the occasion of the 1937 dispute between Honduras and Nicaragua; Honduran representative with plenipotentiary powers at various international congresses and conferences, e.g. the Conference for the Unification of Criminal Law held in Madrid in 1933; envoy extraordinary and minister plenipotentiary, on special mission, at San Jose, Costa Rica; Rio de Janeiro, Brazil; and Santiago, Chile; ambassador extraordinary and plenipotentiary on special mission in the Dominican Republic.

Corresponding member of the Spanish Royal Academy and regular member of the Honduran Linguistic Academy, of which he is permanent secretary. Delegate at the First Congress of Spanish Language Academics, held at Mexico City in 1952. Delegate at the Inter-American Press Congress, held at Bogota, Colombia, in 1946. Member of the American Institute of International Law and of various Honduran and foreign scientific and literary societies.

Has been a journalist from his youth and director of several important newspapers in Honduras, El Salvador and Guatemala. Is at present owner and manager of EL DIA, an important press undertaing in Honduras.

Has received various decorations.

Born 1886.

Member of the International Law Commission, of the Permanent Court of Arbitration and of the Greek Prize Court; Director of the Legal Department of the Ministry of Foreign Affairs of Greece; President or member of several administrative committees in Greece; President of the Greek Society on International Law; President of the Greek Branch of the International Law Association; member of the Administrative Council of the Greek Institute of International and Foreign Law.

Teacher of International Iaw and of Public General Iaw at the University of Kiel, 1927; Professor of Public International Iaw at Salonika, 1928 and Dean of the Faculty of Iaw of this University for three years; Professor of International Iaw at the University of Athens and Dean of the Faculty of this University, 1939-1940; rector of the University of Athens 1947-1948. Iectured for several years on private international law and constitutional law.

Delegate of Greece to the Conference on the Codification of International Law 1930; delegate of Greece to the Balkan Conferences 1930-1933 and member of the Council of the Balkan Conferences 1930-1933; drew up the preliminary draft of the Balkan pact of non-aggression, arbitration and mutual assistance which was adopted by the Third Balkan Conference; delegate of Greece to the Committee of Jurists, Washington, convened to draft the Statute of the International Court of Justice; legal adviser to the Greek delegation to the San Francisco Conference on International Organization; legal adviser to the Greek delegation to the first session of the General Assembly, 1946; legal adviser to the Greek delegation to the Paris Peace Conference, 1946; delegate to the United Nations General Assembly 1947 and 1948-1949 (Rapporteur of the Sixth Committee); Alternate Delegate to the General Assembly, 1949; Delegate to the Eighth Session of the General Assembly, 1953 (Rapporteur of the Sixth Committee).

de VISSCHER, Charles

Born 1884.

Member of the International Court of Justice 1946-1952; member of the Permanent Court of Arbitration since 1923.

Professor of Public and Private International Law at the Universities of Chent and Louvain; editor, since 1920, of the Review of International Law and Comparative Legislation; member of the Institute of International Law since 1921, Secretary-General 1925-1937 and president 1947-1948.

Poctor honoris causa of the Universities of Paris, Nancy and Montpellier; titular member of the Royal Academy of Relgium and delegate of this Academy to the International Academic Union; President of the International Academic Union, 1947-1950; President of the Institute of International Relations (Brussels) since 1947; corresponding member of the Institute of France (Academy of Moral and Political Sciences), of the Academy of Moral Sciences of Madrid and of the Institute of Moral and Political Sciences of Romania; member of the governing body of the Hague Academy of International Law; honorary member of the American Society of International Law.

Past president or member of many permanent commissions of conciliation and arbitration set up under the League of Nations.

Various assignments with the League of Nations, in particular as member and rapporteur of the Committee to amend the Covenant and of the Committee for the Study of Conciliation Procedure; member of the Committee of Jurists established after the Corfu incident and of the Committee of Experts for the Progressive Codification of International Law. Belgian delegate to the first Conference on the Codification of International Law and rapporteur of the third committee of this conference.

Appeared before the Permanent Court of International Justice at the Hague in many leading international lawsuits and was elected to that court in 1937.

Member of the Belgian Liberation Government, 1944-1945; in 1945 represented Belgium on the Committee of Jurists in Washington for the drafting of the Statute of the International Court of Justice, at the United Nations Conference on International Organization in San Francisco, at the London Conference on Intellectual Co-operation and at the first part of the first session of the General Assembly in London.

Author of more than eighty publications dealing with international law, the wost important of which have appeared in the Review of International Law and Comparative Legislation and in the Recueil de Cours de l'Académie de Droit international de La Haye.
