Opening of the session

Opening statements

The temporary Chairman, Mr. Mothetjoa Metsing (Lesotho), Vice-Chairman of the Commission, opened the session and made a statement.

Election of officers

The Commission elected H.E. Dr. Maximus J. Ongkili, Minister of Science, Technology and Innovation of Malaysia as Chairman of the eleventh session to replace H.E. Data' Sri Jamaludin Jarjis (Malaysia) who was not in a position to serve as Chairman.

The Commission also elected Mr. Luciano Parodi (Chile) to replace Mr. Juan Eduardo Eguiguren (Chile) who was not in a position to serve as Vice Chairman.

Presentation by representatives of the United Nations Regional Commissions

The Commission heard a presentation by H.E. Mr. Janis Karklins, former President WSIS PrepCom, Tunis Phase.

Presentations were made by the Executive Secretary, ECE, and by the representatives of ECLAC, ESCWA and ECA.

A presentation was also made by the representative of the European Commission.

Dialogue on regional experiences with WSIS implementation

The Commission held a dialogue on regional experiences with WSIS implementation, which was moderated by Mr. Marek Belka, Executive Secretary, ECE.

The Panelists, H.E. Mr. Miguel Angel Alcaine Castro of El Salvador, H.E. Mr. Anwar Battikhi, Secretary-General of the Higher Council for Science and Technology, Jordan, Mr. Tariq Ur-Rahman, Chairman, Pakistan Council for Science and Technology and H.E. Mr. Joachim Tankoano, Minister for Information and Communication Technology, Burkina Faso engaged in a dialogue with the delegation of the Dominican Republic.
