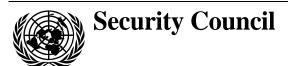

Summary statement by the Secretary-General on matters of which the Security Council is seized and on the stage reached in their consideration

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to submit the list of items of which the Security Council is currently seized. The last full list of items (S/2008/10/Add.17) was issued on 7 May 2008. The last weekly addendum (S/2008/10/Add.21) covered developments up to 31 May 2008.

As the present addendum is the first to be issued in June 2008, it contains a full, updated list of items of which the Security Council is seized, indicating the date on which each item was first taken up by the Council at a formal meeting, and the date of the most recent formal Council meeting held on that item.¹

Set out below are the items on which the Security Council took action during the week ending 7 June 2008. The dates given for each item indicate when the item was first taken up by the Council at a formal meeting, and the most recent formal Council meeting held on that item.

The situation in the Middle East (18 July 1960; 2 June 2008)

The Security Council resumed its consideration of the item at its 5901st meeting, held on 2 June 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representative of Lebanon, at his request, to participate in the consideration of the item without the right to vote. The Council proceeded to vote on draft resolution S/2008/349, submitted by France, and adopted it unanimously as resolution 1815 (2008).

The situation in Somalia (17 March 1992; 2 June 2008)

The Security Council resumed its consideration of the item at its 5902nd meeting, held on 2 June 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representatives of Australia, Canada, Denmark, Greece, Japan, the Netherlands, Norway, the Republic of Korea, Somalia and Spain, at their request, to participate in the consideration of the item without the right to vote. The Council proceeded to vote on draft resolution S/2008/351, submitted by Australia, Belgium, Canada, Croatia, Denmark, France, Greece, Italy, Japan, the Netherlands, Norway, Panama, the Republic of Korea, Spain, the United Kingdom of Great Britain and Northern Ireland and the United States of America, and adopted it unanimously as resolution 1816 (2008).

Threats to international peace and security caused by terrorist acts (12 September 2001; 2 June 2008)

The Security Council resumed its consideration of the item at its 5903rd meeting, held on 2 June 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representatives of Denmark and Pakistan, at their request, to participate in the consideration of the item without the right to vote. The President, on behalf of the Council, made a statement (S/PRST/2008/19).

Under rule 39 of its provisional rules of procedure, the Council extended invitations to Judge Fausto Pocar, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991; Judge Dennis Byron, President of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States between 1 January 1994 and 31 December 1994; Serge Brammertz, Prosecutor of the International Tribunal for the Former Yugoslavia; and Hassan Bubacar Jallow, Prosecutor of the International Criminal Tribunal for Rwanda.

Reports of the Secretary-General on the Sudan (11 June 2004; 5 June 2008)

The Security Council resumed its consideration of the item at its 5905th meeting, held on 5 June 2008. Under rule 39 of its provisional rules of procedure, the Council extended an invitation to Luis Moreno-Ocampo, Prosecutor of the International Criminal Court.
