# Summary statement by the Secretary-General on matters of which the Security Council is seized and on the stage reached in their consideration

#### Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, and in accordance with paragraph 7 of the note by the President dated 19 December 2007 (S/2007/749), the Secretary-General is submitting the following summary statement.

The complete list of items of which the Security Council was seized as at 5 July 2008 is contained in document S/2008/10/Add.26 of 10 July 2008.

The present addendum lists the items on which the Security Council took action during the week ending 19 July 2008. The dates given for each item indicate when the item was first taken up by the Council at a formal meeting, and the most recent formal meeting of the Council held on that item.

Meeting of the Security Council with the troop-contributing countries pursuant to resolution 1353 (2001), annex II, sections A and B (10 September 2001; 16 July 2008)

### African Union-United Nations Hybrid Operation in Darfur

The Security Council resumed its consideration of the item at its 5934th meeting, held in private on 16 July 2008. At the close of the meeting, in accordance with rule 55 of the provisional rules of procedure of the Security Council, a communiqué was issued through the Secretary-General in place of a verbatim record (S/PV.5934).

#### Reports of the Secretary-General on the Sudan (11 June 2004; 16 July 2008)

The Security Council resumed its consideration of the item at its 5935th meeting, held on 16 July 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representatives of Rwanda and Uganda, at their request, to participate in the consideration of the item without the right to vote. The President, on behalf of the Council, made a statement (S/PRST/2008/27).



## Children and armed conflict (29 June 1998; 17 July 2008)

The Security Council resumed its consideration of the item at its 5936th meeting, held on 17 July 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representatives of Afghanistan, Australia, Austria, Bangladesh, Benin, Canada, Colombia, Côte d'Ivoire, Egypt, Germany, Ghana, Ireland, Israel, Japan, Liberia, Liechtenstein, Malawi, Mexico, Myanmar, Nepal, Nicaragua, Nigeria, Norway, Peru, Rwanda, San Marino, Somalia, Sri Lanka, Uganda and Uruguay, at their request, to participate in the consideration of the item without the right to vote. Under rule 39 of its provisional rules of procedure, the Council extended invitations to Edmond Mullet, Assistant Secretary-General for Peacekeeping Operations; Radhika Coomaraswamy, Special Representative of the Secretary-General for Children and Armed Conflict; Ann Veneman, Executive Director of the United Nations Children's Fund; Kathleen Hunt, Chairperson of the International Steering Committee of Watchlist on Children and Armed Conflict; and Lila Hanitra Ratsifandrihamanana, Permanent Observer of the African Union. The President, on behalf of the Council, made a statement (S/PRST/2008/28).

International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States between 1 January 1994 and 31 December 1994 (29 February 1996; 18 July 2008)

The Security Council resumed its consideration of the item at its 5937th meeting, held on 18 July 2008. The Council proceeded to vote on draft resolution S/2008/467, which had been prepared in the course of the Council's prior consultations, and adopted it unanimously as resolution 1824 (2008).

# Letter dated 22 November 2006 from the Secretary-General addressed to the President of the Security Council (S/2006/920) (1 December 2006; 18 July 2008)

The Security Council resumed its consideration of the item at its 5938th meeting, held on 18 July 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representatives of India, Japan and Nepal, at their request, to participate in the consideration of the item without the right to vote. Under rule 39 of its provisional rules of procedure, the Council extended an invitation to Ian Martin, Special Representative of the Secretary-General in Nepal and Head of the United Nations Mission in Nepal.
