INFORMATION BULLETIN

The Ministers for Foreign Affairs of Colombia, Mexico, Panama and Venezuela met at Panama City on 20 and 21 December with a view to making progress in the work of the Contadora Group.

To that end, they analysed the initiatives and recommendations arising out of the technical meeting held at the deputy minister and adviser level on 1 and 2 December in which representatives of the nine countries took part.

As a result of that examination, the Ministers for Foreign Affairs of the Contadora Group prepared a proposal entitled "Norms for the implementation of the undertakings made in the Document of Objectives", which covers aspects of regional security, policy and joint action in the economic field and which will be submitted to the Central American Governments for their consideration.

The norms provide for specific action aimed at the implementation of the Document of Objectives. They will also serve as basic reference elements for the work of the Fifth Joint Conference of Ministers for Foreign Affairs, which has been convoked for 7, 8 and 9 January, dates which coincide with the first anniversary of the establishment of the Contadora Group.

The Ministers of Colombia, Mexico and Venezuela express their gratitude once again for the hospitality of the Government and people of Panama and for the honour of their interview with Mr. Ricardo de la Espriella, President of the Republic.
