## **Annotations**

### **1. Opening of the session by the representative of the Secretary-General**

The ninth session of the Committee will be opened by a representative of the Secretary-General.

### **2. Adoption of the agenda**

In accordance with rule 7, the Committee may revise the agenda during a session and may, as appropriate, defer or delete items.

### **3. Consideration of reports submitted by States parties under article 73 of the Convention**

At its ninth session, the Committee will consider the initial report received from El Salvador (CMW/C/SLV/1). The Secretary-General has informed the State party concerned that its report is scheduled for consideration by the Committee on Monday 24 November in the afternoon, and on Tuesday 25 November in the morning.
