#### **Report of the Second Committee\***

1. At its 2nd plenary meeting, on 19 September 2008, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-third session the item entitled:

“Eradication of poverty and other development issues:

“(a) Implementation of the second United Nations Decade for the Eradication of Poverty (2008-2017);

“(b) Industrial development cooperation”

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on the item at its 14th, 15th and 16th meetings, on 22 and 23 October 2008.
