#### II. ANNOTATIONS TO THE PROVISIONAL AGENDA

### Item 1: Adoption of the Agenda

2. The Ad Hoc Group of Experts should elect a Bureau or confirm/re-elect the existing Bureau.

# Item 3: Activities and priorities of the Committee on Sustainable Energy and any matters for consideration by the Ad Hoc Group of Experts

3. The secretariat will provide an overview of recent activities within the work programme of the Committee on Sustainable Energy (ECE/ENERGY/78) following its seventeenth session in November 2008, with particular emphasis on any decisions taken with regard to the work of the Ad Hoc Group of Experts.

## Item 5: Recommendations on revision of the United Nations Framework Classification for Fossil Energy and Mineral Resources

**Consideration of recommendations:** 

- (a) to revise the UNFC of 2004;
- (b) with respect to the complementary texts to the UNFC, and;
- (c) with respect to governance of the UNFC
- 5. At its fifth session, the Ad Hoc Group of Experts requested the Bureau (i) to prepare any proposed changes to the UNFC through a due and transparent process, including by posting a draft text on the UNECE website for public comment over a sufficient period of time; (ii) that any proposals, comments and/or recommendations to be submitted to the Extended Bureau of the Committee on Sustainable Energy should be published on the UNECE website; and (iii) to define an appropriate timeline, taking into consideration the guidance of the Director of the UNECE Sustainable Energy Division (ENERGY/GE.3/2008/2, paragraph 18(e)).
- 6. The Ad Hoc Group of Experts additionally requested the Bureau to prepare a discussion paper on Specifications (secondary rules) based on the Mapping Task Force Report and the discussions at the fifth session, including the discussions on the needs of applications pertaining to energy studies and government resource management, business process management and financial reporting (ENERGY/GE.3/2008/2, paragraph 18(f)).
- 6. The meeting will discuss a recommendation from the Bureau with respect to revising the UNFC and the formulation of complementary texts to the Revised UNFC-2008 as developed by a special Task Force on Revision of the UNFC.

### Item 6: International Accounting Standards Board's Research Project on Extractive Activities

7. The International Accounting Standards Board Research Project on Extractive Activities is due to issue a discussion paper on an International Financial Accounting Standard (IFRS) for Extractive Activities. The research undertaken to develop this discussion paper will be reviewed as it pertains to the classification of extractive activities.

# Item 7: United Nations Statistics Division (UNSD)/London and Oslo City Groups' specifications for national energy statistics

8. Two groups of experts from the National Bureaux of Statistics are researching standards for use in national statistics, including in energy statistics. One group, the Oslo Group (http://og.ssb.no/ogwebpage/) is tasked with energy statistics, and another, the London Group (http://unstats.un.org/unsd/envaccounting/londongroup/) is tasked with environmental accounting, including resource accounting. Both bodies are cooperating with UNSD and the InterEnerStat Initiative (see agenda item 8). Reports on their activities will be presented and implications for the work of the Ad Hoc Group of Experts discussed.

# Item 8: InterEnerStat Initiative led by the International Energy Agency on the definitions of energy flows and products

9. InterEnerStat (http://www.iea.org/interenerstat\_v2/) conducted work in 2008 to define energy flows and products. The activities of InterEnerStat will be presented and discussed as they relate to the work of the Ad Hoc Group of Experts.

### **Item 9:** Classification of recipient reservoirs

- 10. The Ad Hoc Group of Experts has been encouraged to review the application of the UNFC to injection projects. The discussions at the fifth session confirmed the merit of considering the classification of recipient reservoirs in conjunction with the classification of producing reservoirs.
- 11. The meeting will focus on future potential work on this topic and possible synergies with the UNECE Working Party on Gas, which is currently looking at gas storage issues, and the Ad Hoc Group of Experts on Cleaner Electricity Production from Coal and Other Fossil Fuels, which has the issue of carbon capture and storage on its programme of work.

# Item 10: Possible implications of agenda items 5 to 9 on the UNFC and any texts to be developed or adopted to supplement the UNFC.

12. Following the discussions on agenda items 5 to 9, any possible implications thereof on the proposed revised UNFC will be discussed.

13. The recent work and future planned activities of the International Energy Forum will be discussed, including how this might relate to the work of the Ad Hoc Group of Experts and possible synergies.

15. The Ad Hoc Group of Experts will be given an opportunity to discuss and review the programme of work for 2009/2010 and to propose specific activities to be carried out during this period.
