

E. Summary of cases that merit special attention

- 6. The Tribunal would like to draw the attention of the General Assembly to a number of judgements distributed in 2008 that it considers to be landmark decisions expanding its jurisprudence. A short summary of each of these judgements is set out below.
- 7. Judgement No. 1386, Nhliziyo, was rendered on 25 July 2008 and distributed on 8 October. The Tribunal agreed with the Joint Appeals Board that the appeal, which was filed in October 2003 more than a year after the time limit prescribed in staff rule 111.2 (a), was not receivable, ratione temporis. However, it noted that when, in September 2003, the Board informed the applicant of the time limits in his case and specified that he had to file his appeal within one month or it would be deemed to have been abandoned, his counsel advised the Board of "informal attempts at resolving the matter involving the Ombudsman". The Tribunal stated "in the strongest possible terms" that, while it is commendable for every effort to be made in resolving conflicts via the informal system, such efforts will not be considered to automatically "stop the clock ticking" in the formal system. It recalled in this regard its Judgement No. 1211, Muigai (2004), where the Tribunal found that "negotiations between the parties do not stop the time from running. While negotiations are to be encouraged, they do not in and of themselves necessarily suspend the time limits for initiating the formal proceedings."
- 8. Judgement No. 1388, Comerford-Verzuu, was rendered on 25 July 2008 and distributed on 8 October. The Applicant, acting as the beneficiary of her husband, Dr. C., who died on 18 August 2000 while he was on mission for UNDP in the Democratic Republic of the Congo, requested the Tribunal to rescind the decision to close the case following the refusal of the insurer under the Malicious Acts Insurance Policy to grant her compensation. She also made various additional requests for compensation, including for the failure on the part of the respondent to safeguard her husband's personal safety, health and welfare.
- 9. The case arose because it had been impossible to determine whether Dr. C.'s death was attributable to homicide or suicide. As it was not the Tribunal's role to make a factual determination on the cause of death, its starting point was the Secretary-General's acceptance of the Advisory Board on Compensation Claims' recommendation that the death "be recognized as being attributable to the performance of official duties on behalf of the United Nations". That decision having been taken, the Tribunal had to determine the extent of the legal obligations it created for the Organization.
- 10. The principal question was whether the applicant's claim, as the dependent widow of the deceased under the Malicious Acts Insurance Policy, which was administered by the Office of the United Nations Security Coordinator through a broker representing the underwriters, was mishandled by the Organization, resulting in substantial economic and moral damage to her and their dependent children. The Tribunal found that the Organization, as the assured and the administrator of claims made by staff members who are insured persons and their beneficiaries, had a duty to act fairly and in good faith. After careful consideration of all the documents submitted by the Office of the United Nations Security Coordinator to the insurers, it concluded, contrary to the Joint Appeals Board, that the Organization had seriously breached both of those specific obligations. Not only had the Office failed

to ensure that there had been as good an investigation as was possible in all the circumstances, but also it had seriously failed to present a fair and impartial description of the circumstances leading to the claim and had prejudiced the outcome by concluding that Dr. C. had committed suicide. In addition, the Tribunal found that the Organization's dealings with the applicant lacked transparency; that she was callously treated; that she was not provided with counselling; that she was consistently denied access, not only to all the documentation sent to the insurer, but even to the text of the relevant Malicious Acts Insurance Policy; and that there were unconscionable delays in the handling of her claim.

11. Accordingly, the Tribunal found that the applicant had established that the Malicious Acts Insurance Policy claim was seriously mishandled by the Organization, in breach of the duty of good faith, and that there was also a serious failure of due process. In the light of this finding, it awarded the applicant compensation in the amount of \$250,000.
