Summary statement by the Secretary-General on matters of which the Security Council is seized and on the stage reached in their consideration

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to submit the list of items of which the Security Council is currently seized. The last full list of items (S/2008/10/Add.43) was issued on 7 November 2008. The last weekly addendum (S/2008/10/Add.47) covered developments up to 29 November 2008.

As the present addendum is the first to be issued in December 2008, it contains a full, updated list of items of which the Security Council is seized, indicating the date on which each item was first taken up by the Council at a formal meeting, and the date of the most recent formal Council meeting held on that item.

Set out below are the items on which the Security Council took action during the week ending 6 December 2008. The dates given for each item indicate when the item was first taken up by the Council at a formal meeting, and the most recent formal Council meeting held on that item.

The situation in Somalia (17 March 1992; 2 December 2008)

The Security Council resumed its consideration of the item at its 6026th meeting, held on 2 December 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representatives of Australia, Canada, Denmark, Greece, Japan, Malaysia, the Netherlands, Norway, Portugal, the Republic of Korea, Singapore, Somalia, Spain and Ukraine, at their request, to participate in the consideration of the item without the right to vote. The Council proceeded to vote on draft resolution S/2008/748, submitted by Australia, Belgium, Canada, Croatia, Denmark, France, Greece, Italy, Japan, Malaysia, the Netherlands, Norway, Portugal, the Republic of Korea, Singapore, Spain, Ukraine, the United Kingdom of Great Britain and Northern Ireland and the United States of America, and adopted it unanimously as resolution 1846 (2008).

The situation in the Central African Republic (6 August 1997; 2 December 2008)

The Security Council resumed its consideration of the item at its 6027th meeting, held on 2 December 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representative of the Central African Republic, at his request, to participate in the consideration of the item without the right to vote. Under rule 39 of its provisional rules of procedure, the Council extended invitations to François Lonseny Fall, Special Representative of the Secretary-General and Head of the United Nations Peacebuilding Support Office in the Central African Republic, and Jan Grauls, Chairperson of the Central African Republic configuration of the Peacebuilding Commission and Permanent Representative of Belgium.

The situation in the Middle East, including the Palestinian question (3 October 2000; 3 December 2008)

The Security Council resumed its consideration of the item at its 6030th meeting, held on 3 December 2008. The Council, under rule 37 of its provisional

rules of procedure, invited the representative of Israel, at her request, to participate in the consideration of the item without the right to vote. In response to the request contained in a letter dated 3 December 2008 from the Permanent Observer of Palestine to the United Nations addressed to the President of the Security Council (S/2008/755), the President, in accordance with the rules of procedure and the previous practice in this regard, invited the Permanent Observer of Palestine to participate in the meeting.

Security Council mission (18 June 2003; 4 December 2008)

The Security Council resumed its consideration of the item at its 6031st meeting, held on 4 December 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representative of Afghanistan, at his request, to participate in the consideration of the item without the right to vote.

Meeting of the Security Council with the troop-contributing countries pursuant to resolution 1353 (2001), annex II, sections A and B (10 September 2001; 5 December 2008)

United Nations Peacekeeping Force in Cyprus

The Security Council resumed its consideration of the item at its 6032nd meeting, held in private on 5 December 2008. At the close of the meeting, in accordance with rule 55 of the provisional rules of procedure of the Security Council, a communiqué was issued through the Secretary-General in place of a verbatim record (S/PV.6032).

The situation in Bosnia and Herzegovina (9 September 1992; 5 December 2008)
