I. INTRODUCTION

- 1. It is recalled that Resolution No. 258 of the Inland Transport Committee with the Plan of action for the implementation of the decisions taken by the pan-European Conference on Inland Water Transport requests the Working Party on Inland Water Transport and its relevant subsidiary bodies to cooperate with River Commissions in order to rationalize and unify as much as possible the requirements on checking the knowledge by boatmasters of specific stretches of inland waterways and their navigating skills on those stretches (ECE/TRANS/192, Annex II, item 2).
- 2. At the meeting of volunteer experts on the mutual recognition of the boatmaster's licences on 18 September 2008, experts recognized that it could be useful to collect the information on

the local knowledge requirements in the UNECE countries (ECE/TRANS/SC.3/WP.3/2009/7, para.19).

- 3. Bearing this in mind, the secretariat in consultation with River Commissions, prepared a draft table which could be used to collect information on the local knowledge requirements existing in the UNECE region.
- 4. The Working Party may wish to consider the format of the table and invite countries and River commissions to assist the secretariat in collecting this information, so that a preliminary document could be present at the next session of SC.3/WP.3 in June 2009.
