Election of members of the functional commissions of the Council

Note by the Secretary-General

1. Pursuant to section V of Economic and Social Council resolution 557 C (XVIII), as amended by the Council in its decision of 19 December 1968, information on the forthcoming vacancies in the functional commissions to be filled by the Council at its resumed organizational session for 2009 is set out in the annex below.

2. Under the terms of Council resolution 1147 (XLI), in 2009 the members of the Statistical Commission, the Commission on Population and Development, the Commission on the Status of Women, the Commission on Narcotic Drugs, the Commission on Crime Prevention and Criminal Justice and the Commission on Sustainable Development are to be elected on the basis of equitable geographical distribution according to a specified pattern. The pattern applicable to each functional commission is indicated in the annex, together with the current membership.
