SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF WHICH THE SECURITY COUNCIL IS SEIZED AND OF THE STAGE REACHED IN THEIR CONSIDERATION

Pursuant to Rule 11 of the Provisional Rules of Procedure of the Security Council, I submit the following Summary Statement on matters of which the Security Council is seized and of the stage reached in their consideration on 2 April 1948.

Discussion was continued at the two hundred and seventy-fifth and two hundred and seventy-seventh meetings. At the two hundred and seventy-seventh meeting the draft resolution (document S/704) introduced by the representative of the United States as amended by the representative of the Ukrainian Soviet Socialist Republic, calling for a truce in Palestine was adopted unanimously. The draft resolution (document S/705) also introduced by the representative of the United States, requesting the Secretary-General to convoke a special session of the General Assembly regarding Palestine, was adopted by nine votes /in favour

in favour with two abstentions (Ukrainian Soviet Socialist Republic and the Union of Soviet Socialist Republics). The Secretary-General announced that the special session of the General Assembly called for by the terms of the United States resolution (S/705) would be convoked on 16 April 1948.
