The meeting was called to order at 10.20 a.m.

Adoption of the agenda and other organizational matters (*continued*) (E/2009/2 and Corr.1; E/2009/L.1)

1. **The President** announced that the Bureau had reached agreement with regard to its division of responsibilities for the 2009 substantive session of the Economic and Social Council. She herself would conduct the high-level segment, the dialogue with the Executive Secretaries of the regional commissions and the conclusion of the work of the 2009 substantive session; Mr. Somduth Soboron (Mauritius), Vice-President, would conduct the coordination segment; Mrs. Carmen María Gallardo Hernández (El Salvador), Vice-President, would conduct the operational activities segment; Mrs. Tiina Intelmann (Estonia), Vice-President, would conduct the humanitarian affairs segment; and Mr. Hamidon Ali (Malaysia), Vice-President, would conduct the general segment.

The meeting was suspended at 10.25 a.m. and resumed at 10.50 a.m.

2. **The President** drew attention to the draft proposals submitted by the President of the Council and members of the Bureau on the basis of informal consultations held pursuant to paragraph 2 (I) of Council decision 1988/77 (E/2009/L.1).
