*Summary*

The Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol, at its seventh session, requested its Chair to prepare a proposal for amendments to the Kyoto Protocol, pursuant to its Article 3, paragraph 9, for consideration at its eighth session. The annex to this document contains proposals for amendments to Annex B to the Kyoto Protocol and consequential amendments to the Protocol flowing from the amendments to Annex B. The annex is based on textual proposals submitted by Parties.

## **Introduction**

### **A. Mandate**

1. The Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol (AWG-KP), at its seventh session, requested its Chair to prepare a proposal for amendments to the Kyoto Protocol pursuant to its Article 3, paragraph 9.<sup>1</sup>
2. At the same session, the AWG-KP invited Parties to submit to the secretariat, by 24 April 2009, further views and proposals on matters relating to this request. It further requested its Chair to consider these submissions, as well as work undertaken and other submissions invited during the seventh session of the AWG-KP, in preparing the proposal.

### **B. Scope of the note**

3. This document has been prepared in response to the request referred to in paragraph 1 above. The annex contains proposals for amendments to Annex B to the Kyoto Protocol and consequential amendments that flow directly from amendments to Annex B. In accordance with the mandate given to the Chair, the text contained in the annex is based on textual proposals by Parties, as presented in the submissions referred to in paragraph 2 above,<sup>2</sup> work undertaken and submissions invited<sup>3</sup> during the seventh session of the AWG-KP, and views submitted by Parties on legal implications arising from the work of the AWG-KP pursuant to Article 3, paragraph 9, of the Kyoto Protocol.<sup>4</sup>
4. The annex contains various options for consideration by Parties. Where feasible, the Chair has merged several textual proposals submitted by Parties or arising from the work undertaken during the seventh session of the AWG-KP into single options with elements in square brackets reflecting the different formulations presented in those proposals. In the options for an amendment to Annex B to the Kyoto Protocol, the Chair has included in the table non-Parties to the Kyoto Protocol, either because the countries concerned have explicitly so requested or their names are included in the textual proposals presented by Parties.

### **C. Possible action by the Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol**

5. The AWG-KP may wish to consider the options contained in the annex with a view to further developing the text by, inter alia, narrowing and refining the options. In the context of its consideration of the relevant options, the AWG-KP may also wish to pay particular attention to the scale of emission reductions to be achieved by Annex I Parties in aggregate and the contribution of Annex I Parties, individually or jointly, consistent with Article 4 of the Protocol, to that scale. In the light of the legal requirement in Article 20, paragraph 2, of the Protocol that the text of any proposed amendment shall be communicated to Parties by the secretariat six months before the meeting at which it is proposed for adoption, arrangements will need to be made to communicate by 17 June 2009 the text of the proposed amendments to Parties.

Annex C would be additional to Annex B, which would continue to exist for ongoing reference and use for end of commitment period accounting and compliance procedures. This new annex would contain not only new quantified emission limitation or reduction commitments, which would be expressed as a percentage of base year emissions and in terms of gigagrams of carbon dioxide equivalent, but also "other quantified mitigation commitments". The adoption of an Annex C would result in consequential amendments that are not reflected in this note since they arise from the proposal to add a new annex and do not flow directly from an amendment to Annex B. The consequential amendments proposed by New Zealand arising from its Annex C option are contained in document FCCC/KP/AWG/2009/MISC.7.

The following paragraph shall be inserted after paragraph 1 of Article 3 of the Protocol:

1 bis. The Parties included in Annex I shall, individually or jointly, ensure that their aggregate anthropogenic carbon dioxide equivalent emissions of the greenhouse gases listed in Annex A do not exceed their assigned amounts, calculated pursuant to their quantified emission limitation and reduction commitments inscribed in the third column of the table contained in Annex B and in accordance with the provisions of this Article, with a view to reducing their overall emissions of such gases by

at least X per cent below [1990][W] levels [in the commitment period 2013 to V]  
[by 2020, T and U respectively],

or

at least 40 per cent below 1990 levels in the second commitment period 2013 to 2018,

or

[at least] [30][40][45] per cent below 1990 levels [in the commitment period 2013 to 2020][by 2020],

[[with the provision of][and in accordance with] the annual compliance assessment set out in Article [7][R]].

***Option 2***

The following paragraph shall be inserted after paragraph 1 of Article 3 of the Protocol:

1 bis. The Parties included in Annex I shall, individually or jointly, ensure that their aggregate anthropogenic carbon dioxide equivalent emissions of the greenhouse gases listed in Annex A do not exceed their assigned amounts, calculated pursuant to their quantified emission limitation and reduction commitments inscribed in Annex B and in accordance with the provisions of this Article, with a view to reducing their overall emissions of such gases by an amount greater than X per cent below 1990 levels in the commitment period 2013 to 2017 that has been determined on the basis of the following criteria in order to ensure consistency with the ultimate objective of the Convention and the principles of equity and common but differentiated responsibilities:

- (a) Historical responsibility of Annex I Parties, individually and jointly, for current atmospheric concentrations of greenhouse gases;
- (b) The historical and current per capita emissions in developed countries;
- (c) Technological, financial and institutional capacities;
- (d) The share of global emissions required by developing countries in order to meet their social and development needs.

**Option 3**

*(would only apply if option 3 for Annex B above is selected)*

The following paragraph shall be inserted after paragraph 1 of Article 3 of the Protocol:

1 bis. The Parties included in Annex I shall, individually or jointly, ensure that their aggregate anthropogenic carbon dioxide equivalent emissions of the greenhouse gases listed in Annex A do not exceed their assigned amounts, calculated pursuant to their quantified emission reduction commitments inscribed in Annex B and in accordance with the provisions of this Article, with a view to reducing their overall emissions of such gases by at least Q per cent below 1990 levels by 2016 and at least S per cent below 1990 levels in the second quantified emissions reduction commitment period ending 2018 to 2022.

**Option 4**

*(would only apply if option 2 for Annex B above is selected)*

The following paragraph shall be inserted after paragraph 1 of Article 3 of the Protocol:

1 bis. The Parties included in Annex I shall, individually or jointly, ensure that their aggregate anthropogenic carbon dioxide equivalent emissions of the greenhouse gases listed in Annex A do not exceed their assigned amounts, calculated pursuant to their quantified emission reduction commitments inscribed in Annex B and in accordance with the provisions of this Article, with [a view to][the objective of] reducing their overall emissions of such gases by

[at least [18][20]][more than 30] per cent below 1990 levels in the second commitment period 2013 to 2017 and [at least [40][45]][more than 50] per cent below 1990 levels in the third commitment period 2018 to 2022.

or

at least 45 per cent below 1990 levels in the commitment period 2013 to 2020 and at least 56 per cent below 1990 levels by 2027.

The following paragraph shall be inserted after paragraph 1 of Article 3 of the Protocol:

1 bis. The Parties included in Annex I shall, individually or jointly, ensure that their aggregate anthropogenic carbon dioxide equivalent emissions of the greenhouse gases listed in Annex A do not exceed, in the commitment period 2013 to V, their respective assigned amounts inscribed in Annex B which are established in a manner ensuring comparability of efforts of each Party included in Annex I, taking into account national and sectoral aspects, in order to take the lead in combating climate change, with a view to contributing to the global efforts towards the peaking-out of the global emissions of greenhouse gases in the next 10 to 20 years, and to ensuring a long-term pathway for each Party included in Annex I towards significant emission reduction.



**C. Article 3, paragraph 1 ter****Option 1**

*(would only apply if option 4 for Article 3, paragraph 1 bis, above is selected)*

The following paragraph shall be inserted after paragraph 1 bis of Article 3 of the Protocol:

1 ter. The Parties included in Annex I shall, individually or jointly, ensure that their aggregate anthropogenic carbon dioxide equivalent emissions of the greenhouse gases listed in Annex A do not exceed their assigned amounts, calculated pursuant to their quantified emission reduction commitments inscribed in Annex B and in accordance with the provisions of this Article, with a view to reducing their overall emissions of such gases by [at least 85][[more than][at least] 95] [at least N] per cent below 1990 levels by 2050. This shall be achieved during subsequent commitment periods by the end of 2050.

**Option 2**

*(would only apply in the case where the proposal under Article 3, paragraph 1 bis, above is for a second commitment period only and not for multiple commitment periods)*

The following paragraph shall be inserted after paragraph 1 bis of Article 3 of the Protocol:

1 ter. The quantified emission limitation or reduction commitments and [...] for the period [...] inscribed in [...] shall only apply once [*specified conditions have been met, for example, a percentage of certain carbon dioxide emissions are covered*], a minimum number of Parties included in Annex I have accepted the amendment, and links to the entry into force of the agreed outcome under the Ad Hoc Working Group on Long-term Cooperative Action under the Convention have been satisfied]].

**D. Article 3, paragraph 7 bis****Option 1**

The following paragraph shall be inserted after paragraph 7 of Article 3 of the Protocol:

7 bis. In the second quantified emission limitation and reduction commitment period, [from [2013 to 2017][ending 2018 to 2022][2013 to 2018][2013 to 2020][2013 to V], the assigned amount for each Party included in Annex I shall be equal [or more] to the percentage inscribed for it in the third column of the table contained in Annex B of its aggregate anthropogenic carbon dioxide equivalent emissions of the greenhouse gases listed in Annex A in 1990, or the base year or period determined in accordance with paragraph 5 above, multiplied by [five][six][eight][Y]. [Those Parties included in Annex I for whom land-use change and forestry constituted a net source of greenhouse gas emissions in 1990 shall include in their 1990 emissions base year or period the aggregate anthropogenic carbon dioxide equivalent emissions by sources minus removals by sinks in 1990 from land-use change for the purposes of calculating their assigned amount.]

**Option 2**

The following paragraph shall be inserted after paragraph 7 of Article 3 of the Protocol:

7 bis. By 2020, T and U, respectively, the assigned amount for each Party included in Annex I shall be equal to the percentage inscribed for it in the third column of the table contained in Annex B of its aggregate anthropogenic carbon dioxide equivalent emissions of the greenhouse gases listed in Annex A in W, or the base year or period determined in accordance with paragraph 5 above, which is P.<sup>5</sup> Those Parties included in Annex I for whom land-use change and forestry constituted a net source of greenhouse gas emissions in 1990 shall include in their 1990 emissions base year or period the aggregate anthropogenic carbon dioxide equivalent emissions by sources minus removals by sinks in 1990 from land-use change for the purposes of calculating their assigned amount.

**Option 3<sup>6</sup>**

The following paragraph shall be inserted after paragraph 7 of Article 3 of the Protocol:

7 bis. In the second commitment period, from 2013 to V, each Party included in Annex I shall elect to use either the number of gigagrams of carbon dioxide equivalent or the percentage of its aggregate anthropogenic carbon dioxide equivalent emissions relative to the base year or period as listed in Annex C<sup>7</sup> for the purpose of calculating its assigned amount in the commitment period. Where no election is made, the percentage of base year or period shall be used to determine the assigned amount. The decision of a Party shall be fixed for the duration of the commitment period as follows:

- (a) For each Party included in Annex I which elects to use the number of gigagrams of carbon dioxide equivalent emissions inscribed in Annex C to express its binding emission limitation or reduction commitment under this Protocol, that number shall constitute its assigned amount;
- (b) For each Party included in Annex I which elects to use the percentage of its carbon dioxide equivalent emissions in the base year or period inscribed in Annex C to express its binding emission limitation or reduction commitment under this Protocol, its assigned amount shall be equal to that percentage of its aggregate anthropogenic carbon dioxide equivalent emissions for the greenhouse gases listed in Annex A in 1990, or the base year or period determined in accordance with paragraph 5 above, multiplied by the number of years in the commitment period.

**E. Article 3, paragraph 7 ter<sup>8</sup>**

The following paragraph shall be inserted after paragraph 7 bis of Article 3 of the Protocol:

7 ter. In the third quantified emission reduction commitment period, from [2018 to 2022] [2020 to 2027], the assigned amount for each Party included in Annex I shall be equal to the percentage inscribed for it in Annex B of its aggregate quantified anthropogenic carbon dioxide equivalent emissions of the greenhouse gases listed in Annex A in 1990, or the base year or period determined in accordance with paragraph 5 above, multiplied by [five][eight].

**F. Article 3, paragraph 7 quater<sup>9</sup>**

The following paragraph shall be inserted after paragraph 7 ter of Article 3 of the Protocol:

7 quater. For the subsequent commitment periods up to 2050, the assigned amount for each Party included in Annex I shall be equal to the percentage to be inscribed in Annex B of its aggregate anthropogenic carbon dioxide equivalent emissions of the greenhouse gases listed in Annex A in 1990, or the base year or period determined in accordance with paragraph 5 above, multiplied by the length of said commitment period, taking into account the need to ensure that Parties included in Annex B meet their aggregate emission reduction commitments as specified in paragraphs 1 bis and 1 ter above.

**G. Article 3, paragraph[s] 9 [and 9 bis]<sup>10</sup>*****Option 1***

In paragraph 9 of Article 3 of the Protocol, for the words:

the consideration of such commitments

there shall be substituted:

the consideration of commitments for the second commitment period

The following paragraph shall be inserted after paragraph 9 of Article 3 of the Protocol:

9 bis. The Conference of the Parties serving as the meeting of the Parties to this Protocol shall initiate the consideration of commitments for the third and subsequent commitment periods at least Z years before the end of the commitment period that immediately precedes the commitment period under consideration.

***Option 2***

Paragraph 9 of Article 3 of the Protocol shall be deleted and replaced by the following paragraph:

9. The Conference of the Parties serving as the meeting of the Parties to this Protocol shall initiate the consideration of a subsequent commitment period at least [five][Z] years before the end of the current commitment period.

***Option 3***

The second sentence of paragraph 9 of Article 3 of the Protocol shall be deleted and the following paragraph shall be inserted after paragraph 9 of Article 3 of the Protocol:

9 bis. The Conference of the Parties serving as the meeting of the Parties to this Protocol shall initiate the consideration of commitments for any further subsequent commitment periods at least [five][seven] years before the end of the commitment period that immediately precedes the commitment period under consideration.

***Option 4***

The following paragraph shall be inserted after paragraph 9 of Article 3 of the Protocol:

9 bis. The Conference of the Parties serving as the meeting of the Parties to this Protocol shall initiate the consideration of [the adequacy of commitments and actions under Articles [...] and] [further] commitments for [any further][the third and] subsequent commitment periods at least [five][Z] years before the end of [the commitment period that immediately precedes the commitment period under consideration][the second and subsequent commitment periods].

***Option 5***

The following paragraph shall be inserted after paragraph 9 of Article 3 of the Protocol:

9 bis. Commitments for subsequent periods for Parties included in Annex I shall be established in amendments to Annex [...] to this Protocol, which shall be adopted in accordance with the provisions of Article 21, paragraph 7. The Conference of the Parties serving as the meeting of the Parties to this Protocol shall initiate the consideration of such commitments at the mid-term review as established in Article 3, paragraph 15, below.

**H. Article 3, paragraph 15<sup>11</sup>**

The following paragraph shall be inserted after paragraph 14 of Article 3 of the Protocol:

15. Commitments set out in Article 3, paragraph 1, shall be subject to a mid-term review on the basis of best available scientific information and compliance of commitments from Parties included in Annex [...]. This review shall occur at the middle of each commitment period (i.e. 2017 for the second commitment period).

The following words shall be added to the end of the first sentence of paragraph 2 of Article 4 of the Protocol:

, or on the date of deposit of their instruments of acceptance of any amendments to Annex B pursuant to Article 3, paragraph 9 [bis]

***Option 2***

In paragraph 3 of Article 4 of the Protocol, for the words:

the commitment period specified in Article 3, paragraph 7

there shall be substituted:

any commitment period established by the Conference of the Parties serving as the meeting of the Parties to this Protocol

***Option 3***

The following paragraph shall be inserted after paragraph 3 of Article 4 of the Protocol:

3 bis. In the second commitment period, any such agreement shall remain in operation for the duration of the commitment period specified in Article 3, paragraph 7 bis.

**ARTICLE 2: ENTRY INTO FORCE**

***Option 1***

This Amendment shall enter into force in accordance with Article 20, paragraphs 4 and 5, of the Protocol.

***Option 2***

1. The provisions of this Amendment shall apply to all Parties immediately upon the conclusion of the first commitment period under Article 3, paragraph 1, of the Protocol, and shall continue to apply on a provisional basis until the entry into force of the Amendment for each Party.

2. This Amendment shall enter into force in accordance with Article 20, paragraphs 4 and 5, of the Protocol.
