This is excellent news for the United Nations generally, but has naturally led to a change in the development community in Seoul and/or Incheon: the United Nations country team is extremely limited, although there are two United Nations regional offices, namely APCICT and ISDR (a global programme managed by OCHA), which are based in Incheon.

Originally focused on security issues in the subregion, CICA now extends its activities to socioeconomic, ecological and humanitarian programmes as essential elements in assuring long-term security.
