REPORT OF THE SUB-COMMISSION ON PREVENTION OF DISCRIMINATION AND PROTECTION OF MINORITIES ON ITS THIRTY-FIRST SESSION

Question of slavery and the slave trade in all their practices and manifestations, including the slaverylike practices of apartheid and colonialism

# Note by the Secretary-General

- 1. Under paragraph 3 of Economic and Social Council resolution 1330 (XLIV) of 31 May 1968, the Secretary-General, in consultation with the Sub-Commission on Prevention of Discrimination and Protection of Minorities, established a list of experts in economic, sociological, legal and other relevant disciplines, whose advice was available to States concerned with the liquidation of slavery and the slave trade in all their practices and manifestations, including the slavery-like practices of apartheid and colonialism. The list was approved by the Commission on Human Rights at its twenty-seventh session, 1/ and was transmitted to Governments of States Members of the United Nations and of the specialized agencies.
- 2. In paragraph 15 of resolution 6 B (XXXI) of 13 September 1978, the Sub-Commission on Prevention of Discrimination and Protection of Minorities requested the Secretary-General "to update the list of experts established under Economic and Social Council resolution 1330 (XLIV) of 31 May 1968".
- 3. Accordingly, in a letter dated 30 November 1978, the Secretary-General invited all Member States to forward to him, if possible by 31 December 1978, the names and curricula vitae of any persons they might wish to suggest for inclusion in the updated list of experts, in order to enable the Secretary-General to submit it to the Commission on Human Rights at its thirty-fifth session.
- 4. The present document contains the names and <u>curricula vitae</u> of persons nominated by Governments for inclusion in the updated list of experts, received by the Secretary-General as of 15 January 1979. 2/ Nominations received after that date vill be included in addenda to this document.
