#### REPORT OF THE SUB-COMMISSION ON PREVENTION OF DISCRIMINATION AND PROTECTION OF MINORITIES ON ITS THIRTY-FIRST SESSION

Question of slavery and the slave trade in all their practices and manifestations, including the slaverylike practices of apartheid and colonialism

#### Note by the Secretary-General

1. In addition to the candidatures contained in document E/CH.4/1299, the Secretary-General has received nominations from the Governments of Colombia and Peru of names for inclusion in the updated list of experts in economic, sociological, legal and other relevant disciplines, whose advice would be available to States concerned with the liquidation of slavery and the slave trade in all their practices and manifestations, including the slavery-like practices of apartheid and colonialism.
