> APPOINTMENTS TO FILL VACANCIES IN THE MEMBERSHIP OF SUBSIDIARY ORGANS OF THE GENERAL ASSEMBLY

International Civil Service Commission

Note by the Secretary-General

- The International Civil Service Commission, established by the General Assembly in 1974 (resolution 3357 (XXIX)) for the regulation and co-ordination of the conditions of service of the United Nations common system, consists of 15 members appointed by the General Assembly, of whom two, designated Chairman and Vice-Chairman, serve full-time. In accordance with article 5, paragraph 1, of the statute of the Commission, the members of the Commission are appointed by the General Assembly for a term of four years and may be reappointed. Of the members initially appointed, the terms of five members expire at the end of three years.
- 2. The present membership of the Commission is as follows:

- 3. Since the terms of office of Mr. Hagiwara, Mr. Hampton, Mr. Hillis, Mr. Fonseca Pimentel and Mr. Plihon expire on 31 December 1977, it will be necessary for the General Assembly at its thirty-second session to appoint five persons to fill the resulting vacancies. The persons so appointed will serve for a period of four years, beginning on 1 January 1978.
- 4. In accordance with article 4 of the statute of the Commission, the Secretary-General, in his capacity as Chairman of the Administrative Committee on Co-ordination, shall, after appropriate consultations with Member States, with the executive heads of the other organizations and with staff representatives, submit to the General Assembly a list of the names of candidates to replace members whose terms of office would expire. It is suggested that the Fifth Committee, after consideration of the list compiled by the Secretary-General, submit to the General Assembly a draft resolution containing the names of the persons recommended for appointment.
