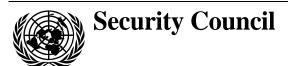

# Letter dated 31 July 2009 from the Secretary-General addressed to the President of the Security Council

I have the honour to refer to article 12 bis, paragraph 2, of the statute of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States between 1 January 1994 and 31 December 1994, which reads:

In the event of a vacancy in the Chambers amongst the permanent judges elected or appointed in accordance with this article, after consultation with the Presidents of the Security Council and of the General Assembly, the Secretary-General shall appoint a person meeting the qualifications of article 12 of the present Statute, for the remainder of the term of office concerned.

In this connection, I wish to inform you that Judge Sergei Alekseevich Egorov (Russian Federation) has resigned.

The Government of the Russian Federation has nominated Professor Bakhtiyar Tuzmukhamedov to replace Judge Egorov. The curriculum vitae of Professor Bakhtiyar Tuzmukhamedov is attached (see annex).\*

It is my view that Professor Tuzmukhamedov meets the qualifications that are prescribed in article 12 of the statute of the International Tribunal.

I should also recall that, in resolution 1878 (2009) adopted on 7 July 2009, the Security Council decided that, notwithstanding article 11, paragraph 2, of the statute of the International Tribunal, and on an exceptional basis, Judge Egorov, once replaced as a member of the International Tribunal, should complete the cases which he began before his resignation.

In accordance with article 12 bis, paragraph 2, of the statute of the International Tribunal, I look forward to receiving your views on the appointment of Professor Tuzmukhamedov as a permanent judge of the International Tribunal.
