Extensions of ongoing country programmes

Note by the secretariat

In accordance with Executive Board decision 2009/11, this note informs the Executive Board of the one-year extensions of the following country and area programmes approved by the Executive Director: Azerbaijan, Chile, the Democratic People's Republic of Korea, the Islamic Republic of Iran, Palestinian children and women, Serbia, Somalia and Uruguay.

The note further presents the reasons for the proposed two-year extensions of the country programmes for the Philippines and Mozambique, which the Executive Board is requested to approve.

Draft decision

The Executive Board

- 1. Takes note of the one-year extensions of the country and area programmes approved by the Executive Director, as indicated in table 1, for Azerbaijan, Chile, the Democratic People's Republic of Korea, the Islamic Republic of Iran, Palestinian children and women, Serbia, Somalia and Uruguay;
- 2. *Approves* the two-year extensions for the Philippines and Mozambique, as presented in table 2.

The Government has requested an extension of the current UNDAF by two years, through end-2011.	With concurrence of the Regional Directors Team, UNDP, UNFPA and UNICEF have requested a two-year extension of the respective country programmes in order to align them with the extended UNDAF.	While the country programme will not witness any major changes, the midterm review recommended reducing the focus areas of UNICEF cooperation and increasing support to national-level programme. The programme performance assessment in late 2008 recommended strengthening UNICEF engagement in national policy development and aligning the programme more clearly with other major partners. The two-year extension will therefore focus on enhancing partnerships, in alignment with national development plans, to strengthen capacity to achieve the Millennium Development Goals in those areas where progress is most lacking for children and to introduce more major shifts in the next country programme.
