# Election of one member of the International Narcotics Control Board from among candidates nominated by Governments

# Note by the Secretary-General

# Addendum

1. The Secretary-General was informed on 24 April 2009 of the resignation of María Elena Medina-Mora Icaza (Mexico), an elected member of the International Narcotics Control Board. Ms. Medina-Mora's term of office started on 2 March 2007 and would have expired on 1 March 2012.

2. Ms. Medina-Mora was elected by the Economic and Social Council in 2006 from among the candidates nominated by Governments pursuant to article 9, paragraph 1 (b), of the Single Convention on Narcotic Drugs of 1961, as amended by the 1972 Protocol (see Council decision 2006/201 B). Accordingly, the member to be elected to fill the remainder of the term should be elected from a list of candidates nominated by Governments.

3. In accordance with established procedure and the provisions of the 1961 Convention, the Secretary-General, on 13 May 2009, invited States Members of the United Nations and those States parties to the 1961 Convention that were not members of the United Nations to nominate candidates by 30 June 2009.

4. As at 6 July 2009, six candidates had been nominated by Governments. Their names are listed below in alphabetical order:
