A. PROPOSAL

Paragraph 17.1.7.1, amend to read:

"17.1.7.1. Notwithstanding the provisions of paragraph 17.1.7., motor vehicles of categories M_2 , M_3 , N_2 , N_3 and M_1 **type SA 4**/ having a maximum total mass > 3500 kg may be fitted with a heating system to heat the passenger compartment which is connected to the LPG-system."

B. JUSTIFICATION

Regulation No. 67 (paragraph 17.1.7.1) currently prohibits the use of a single LPG tank for both the engine and the heating system for Class M_1 not exceeding 3.5 t, a category which includes the majority of motor caravans.

About 90,000 motor caravans are sold each year in Europe alone, most of which are diesel powered. Most of these vehicles are equipped with a heating system fuelled by LPG to heat the passenger compartment.

Allowing M_1 type SA vehicles to rely on a single LPG tank compliant with Regulation No. 67 in its 01 series of amendments would further raise the safety level of those vehicles while increasing the comfort and convenience aspects for customers.
