II. ANNOTATIONS TO THE PROVISIONAL AGENDA

1. ADOPTION OF THE AGENDA

In accordance with Chapter III, Rule 7 of the Rules of Procedure of the World Forum for Harmonization of Vehicle Regulations (WP.29) (TRANS/WP.29/690), the first item on the provisional agenda is the adoption of the agenda.

2. GLOBAL TECHNICAL REGULATION No. 1 (Door locks and door retention components)

(a) Proposal for draft amendments

GRSP may wish to resume consideration of this subject on the basis of the proposal by the expert from the United States of America to amend gtr No. 1 and to consider the proposals from the experts of Japan, the International Organization of Motor Vehicle Manufacturers (OICA) and of the European Community (EC).

3. GLOBAL TECHNICAL REGULATION No. 7 (Head restraints)

(a) Proposal for draft amendments

GRSP agreed to resume consideration of this subject on the basis of the decision taken by WP.29 and the Executive Committee of the 1998 Agreement (AC.3) during their March 2009 sessions.

4. GLOBAL TECHNICAL REGULATION No. 9 (Pedestrian safety)

(a) Flexible legform impactor

GRSP agreed to resume consideration of this subject on the basis of new information by Japan regarding the studies in progress. Concerning the incorporation of the flexible pedestrian legform impactor (Flex-PLI) provisions in phase 2 of the gtr, GRSP agreed to continue consideration of this matter, awaiting the formal proposal for the amendment of the gtr.

(b) Proposal for draft amendments

GRSP agreed to resume consideration of this subject on the basis of the decision taken by WP.29 and the Executive Committee of the 1998 Agreement (AC.3) during their March 2009 sessions.

5. SIDE IMPACT

(a) Exchange of views on side impact

GRSP agreed to resume discussion on this subject.

6. CRASH COMPATIBILITY

- (a) Exchange of view on vehicle crash compatibility

GRSP may wish to consider further proposals on this subject, if any.

7. HYDROGEN AND FUEL CELL VEHICLES

- (a) Subgroup on Safety (HFCV-SGS)

GRSP is expected to be informed about the results of the fifth meeting of the sub-group on safety held in Budapest on 19-23 January 2009.

8. REGULATION No. 11 (Door latches and hinges)

- (a) Alignment to gtr No. 1 (Door locks and door retention components)

GRSP agreed to continue consideration of this subject on the basis of new proposals, if available.

9. REGULATION No. 12 (Steering wheel)

- (a) Proposal for draft amendments

GRSP agreed to continue consideration of the proposals tabled by the expert from Japan and France.

10. REGULATION No. 14 (Safety-belt anchorages)

- (a) ISOFIX anchorages

GRSP may wish to continue consideration of the proposal of the expert from Germany concerning identification markings of upper tether anchorages, pending clarifications from the expert of the United States of America on voluntary industry standards. Furthermore, GRSP agreed to consider a new proposal, tabled by the experts from Germany, Japan, the Netherlands and the United Kingdom, in order to clarify whether ISOFIX positions are required on vehicle types often referred to as 2+2 seat, if available.

11. REGULATION No. 16 (Safety-belts)

- (a) Proposal for draft amendments

GRSP may wish to consider the proposal tabled by the expert from Japan and CLEPA in order to introduce a few corrections to Supplement 1 to the 05 series of amendments to Regulation No. 16. Furthermore, GRSP agreed to consider a new proposal, tabled by the experts from the Russian Federation regarding the voluntary requirement for the installation of safety-belts in

Class II buses. Finally, GRSP agreed to continue consideration of a proposal prepared by the expert from the European Association of Automotive Suppliers (CLEPA) in order to remove any ambiguity in the emergency locking retractor test.

12. REGULATION No. 17 (Strength of seats)

(a) Proposal for draft amendments

GRSP might wish to continue consideration of this subject on the basis of a new proposal voluntarily prepared by the expert from Germany, if available.

(b) Alignment to the gtr No. 7 (Head restraints)

GRSP agreed to continue consideration of the proposal tabled by the EC and Japan experts in order to transpose the draft gtr on head restraints into Regulation No. 17 as well as to allow Contracting Parties to transpose into their national or regional law alternative test procedures for the dynamic assessment of head restraints.

13. REGULATION No. 22 (Protective helmets)

(a) Safety helmets assessment and rating programme (SHARP)

GRSP might wish to continue consideration of the results of the safety helmet assessment and rating programme (SHARP). Furthermore, GRSP might wish to consider a proposal related to the contact of helmets and sharp edges of guardrails tabled by the expert from Malaysia, if available.

14. REGULATION No. 29 (Cabs of commercial vehicles)

(a) Proposal for draft 03 series of amendments

GRSP agreed to resume consideration of this subject on the basis of a new proposal prepared by the informal group, if available.

15. REGULATION No. 44 (Child restraints)

(a) Proposal for draft amendments

GRSP is expected to be informed about the work progress of the informal group on the revision of Regulation No. 44. Furthermore GRSP agreed to consider a proposal tabled by the expert from France in order to solve interpretation anomalies subsequent to approval being granted with reference to Regulation No. 44.

16. REGULATION NO. 94 (Frontal collision)

(a) Proposal for draft amendments

GRSP is expected to be informed about the work progress of the informal group on frontal impact.

17. BUSES AND COACHES

(a) Frontal collision of buses and coaches

With regard to the presentation tabled by the expert from Spain, introduced during GRSP December 2008 session, GRSP might wish to continue consideration of this subject on the basis of new proposals, if available.

(b) Restraining of children travelling in buses and coaches

GRSP might wish to resume consideration of this subject in conjunction with the presentation of the work progress of the informal group on the revision of Regulation No. 44.

(c) Safety of wheelchair users in buses and coaches

GRSP experts agreed to express their views on the development of requirements regarding this issue.

(d) Safety on board of sleeper coaches

GRSP agreed to resume discussion on this subject following the conclusions of the Working Party on Road Traffic Safety (WP.1) relating to the development of provisions on this matter.

18. PROPOSAL FOR DRAFT AMENDMENTS TO REGULATION No. 100 (Construction and functional safety of battery electric vehicles)

GRSP agreed to resume the discussion of this agenda item, on the basis of a consolidated proposal tabled by the informal group on electric safety (ELSA), if available.

19. DRAFT REGULATION ON PEDESTRIAN SAFETY

GRSP agreed to resume the discussion of this agenda item, on the basis of a proposal tabled by the expert from OICA.

20. OTHER BUSINESS

(a) Exchange of information on national and international requirements on passive safety

GRSP may wish to have an exchange of information about the ongoing national legislative developments on this subject.
