Mr. VALENTIN XENOPHONTOVICH PALAMARCHUK

Born 1918. Higher education: Economics and history. From 1939 to 1952 worked in State institutions of the USSR. In 1952 entered the diplomatic service in the Ministry of Foreign Affairs of the USSR.

From 1954 to 1959 was Second Secretary at the Embassy of the USSR to the Romanian People's Republic. From 1959 to 1963 served in the International Organizations Department of the Ministry of Foreign Affairs of the USSR.

From 1963 to 1964 was First Secretary at the Embassy of the USSR to Thailand. In 1964-1966 worked as First Secretary, responsible for United Nations administrative and budgetary questions, in the International Organizations Department of the Ministry of Foreign Affairs. In 1966-1972 was First Secretary, and later Counsellor, of the Permanent Mission of the USSR to the United Nations.

From 1973 to August 1978, served in Ministry of Foreign Affairs of the USSR, first as Counsellor in the International Organizations Department and, from 1976, as Chief, IOD Personnel Administration, Ministry of Foreign Affairs of the USSR.

Since August 1978 has been Senior Counsellor, Permanent Mission of the USSR to the United Nations.

Has participated in many General Assembly sessions (Fifth Committee). Represented the USSR in the Committee on Conferences and other Committees.

From 1970 to 1973 was a member of the United Nations Advisory Committee on Administrative and Budgetary Questions.

At the thirty-second session of the General Assembly was elected to membership of the United Nations Advisory Committee on Administrative and Budgetary Questions for the period from 1 January 1978 to 31 December 1978.

Mr. Palamarchuk is married and has two children.

Mr. GEORGE F. SADDLER

Mr. George F. Saddler is presently Minister-Counselor for Resources Management in the United States Mission to the United Nations. Mr. Saddler has been associated with United Nations activities since February 1965, when he joined the Department of State as an International Administration Officer and concentrated almost exclusively on United Nations administrative, budgetary, financial and personnel matters.

In July 1968, Mr. Saddler joined the Secretariat of the United Nations as Senior Budget Officer in the Budget Division, Office of Financial Services. In January 1971, Mr. Saddler was promoted to Chief of the Economic, Social and Human Rights Section of the Budget Division, where he served until March 1974. While with the Budget Division, Mr. Saddler was assigned Secretariat duties with the Fifth Committee, the Economic and Social Council, the Committee for Programme Co-ordination, the Committee on Natural Resources, the Commission on Human Rights and a number of other United Nations bodies.

From March 1974 until July 1978, Mr. Saddler served with the United Nations Development Programme, first as Deputy Director of the Division of Finance, and from November 1974, as Director of the Division of Finance. In July 1978, he joined the United States Mission to the United Nations.

Prior to joining the Department of State and working on United Nations questions, Mr. Saddler was Supervisor of the Accounting Department of a large retail establishment for seven years. Subsequently, he was the Senior Accountant in the Office of the City Controller for the City of Chicago for eight years. During this period, Mr. Saddler's duties covered a very broad range of financial, accounting, budgetary, administrative and managerial responsibilities, in addition to supervising a large number of professional, clerical and secretarial staff.

Mr. Saddler has a Bachelor of Science Degree in accounting from New York University (1950) and has undertaken post-graduate study in Business Administration at Northwestern University and the University of Chicago.

Mr. Saddler was born 27 September 1925 in Memphis, Tennessee. He is married to Pauline McKissack Saddler, also of Memphis, Tennessee and has two daughters, Paula and Paulette.
