UNITED NATIONS ADMINISTRATIVE TRIBUNAL

Note by the Secretary-General

1. As indicated in document A/33/125 of 30 May 1978, two vacancies will arise in the membership of the United Nations Administrative Tribunal as a result of the expiration, on 31 December 1978, of the terms of office of Mr. Francisco Forteza and Mr. Endre Ustor.
2. Mr. Forteza (Uruguay) and Mr. Ustor (Hungary) have been nominated by their respective Governments for reappointment for terms of office of three years beginning 1 January 1979.
3. The candidates' curricula vitae follow:

Dr. Francisco Forteza

Born in Montevideo, Uruguay, 1 February 1928.

Studied at the Faculty of Law and Social Sciences, University of Montevideo.

Entered the Uruguayan Foreign Service in 1951. In the same year was appointed Secretary of the Permanent Mission of Uruguay to the United Nations.

Secretary of the Uruguayan delegation to the sixth session of the General Assembly, Paris, 1951.

Alternate delegate of Uruguay on the Executive Board of UNICEF.

Alternate delegate of Uruguay on the Commission on Human Rights.

Secretary of the Uruguayan delegation to the fourteenth session of the Economic and Social Council.

Secretary of the Uruguayan delegation to the seventh session of the General Assembly and alternate delegate on the Fourth Committee.

Member of the United Nations Joint Staff Pension Board.

Alternate delegate of Uruguay on the Committee on Restrictive Trade Practices, New York, 1953.

Secretary of the Uruguayan delegation to the sixteenth session of the Economic and Social Council, Geneva, 1953.

Secretary of the Uruguayan delegation to the eighth session of the United Nations General Assembly.

Director of the United Nations Section of the Uruguayan Ministry of Foreign Affairs, 1954.

Adviser of the Uruguayan delegation to the ninth and tenth sessions of the United Nations General Assembly.

Rapporteur of the Fifth Committee at the eleventh session of the United Nations General Assembly.

Endré Ustor, born in Budapest, 1909;

Doctor of Laws, University of Pécs (Hungary) 1932;

Honorary Professor at the Karl Marx University of Economics, Budapest;

Ambassador; Legal Adviser and Head of International Law Department, Ministry for Foreign Affairs (1953-1975);

Member of the Permanent Court of Arbitration;

Member of the Arbitration Tribunal of the Hungarian Chamber of Commerce;

Member of the United Nations International Law Commission and its Chairman in 1974-1975;

Associated member of the Institute of International Law;

Member of the International Law Association, Vice-Chairman of the Hungarian Branch;

Member of the United Nations Administrative Tribunal;

Representative of Hungary in the Sixth Committee of the United Nations General Assembly at its twelfth to twenty-first sessions (1957-1966), at its twenty-fourth (1969) and twenty-ninth (1974) sessions;

Presided over the Hungarian delegation in several United Nations and other diplomatic conferences;

Lectured on "Decision-making in the Council for Mutual Economic Assistance" at the Hague Academy of International Law in 1971;

Author of numerous publications in the field of international law.
