

## Summary statement by the Secretary-General on matters of which the Security Council is seized and on the stage reached in their consideration

## Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to submit the list of items of which the Security Council is currently seized. The last full list of items (S/2009/10/Add.39) was issued on 5 October 2009. The last weekly addendum (S/2009/10/Add.42) covered developments up to 24 October 2009.
