Organization of the sixty-fourth regular session of the General Assembly, adoption of the agenda and allocation of items

Second report of the General Committee

1. At its 2nd meeting, on 24 November 2009, the General Committee considered a request submitted by France and Malta (A/64/232) for the inclusion in the agenda of the sixty-fourth session of an additional item entitled:

"Observer status for the Parliamentary Assembly of the Mediterranean in the General Assembly".

In that connection, the General Committee decided to recommend to the General Assembly that the item:

- (a) Be included in the agenda under heading I (Organizational, administrative and other matters);
 - (b) Be allocated to the Sixth Committee.
- 2. At the same meeting, the General Committee also considered a request submitted by Azerbaijan, Benin, Colombia, Costa Rica, Haiti, Kyrgyzstan, Mexico, the Philippines, Portugal, Slovenia, Timor-Leste and the United Republic of Tanzania (A/64/233) for the inclusion in the agenda of the sixty-fourth session of an additional item entitled:

"Cooperation between the United Nations and the International Organization for Migration".

In that connection, the General Committee decided to defer its consideration of the inclusion of the item.

3. Also at the same meeting, the General Committee considered a request submitted by the Secretary-General (A/64/234) for the inclusion in the agenda of the sixty-fourth session of an additional item entitled:

"United Nations University".

In that connection, the General Committee decided to recommend to the General Assembly that the item:





- (a) Be included in the agenda under heading B (Promotion of sustained economic growth and sustainable development in accordance with the relevant resolutions of the General Assembly and recent United Nations conferences);
 - (b) Be allocated to the Second Committee.
- 4. At the same meeting, the General Committee also considered a request submitted by Saint Lucia, Saudi Arabia and Ukraine (A/64/235) for the inclusion in the agenda of the sixty-fourth session of an additional item entitled:
 - "Observer status in the General Assembly for the Council of Presidents of the General Assembly".

In that connection, the General Committee decided to recommend to the General Assembly that the item:

- (a) Be included in the agenda under heading I (Organizational, administrative and other matters);
 - (b) Be allocated to the Sixth Committee.
- 5. At its 1st meeting, on 16 September 2009, the General Committee decided (A/64/250, para. 50) to defer to a later date its consideration of the inclusion of the item entitled "Question of the Comorian island of Mayotte". At its 2nd meeting, on 24 November 2009, the General Committee decided to recommend to the General Assembly that this item be included in the agenda of the sixty-fourth session under heading A (Maintenance of international peace and security) on the understanding that there would be no consideration of this item by the General Assembly until further notice.
