Jamaica: draft resolution\*

## Conference of plenipotentiaries on the establishment of the United Nations Industrial Development Organization as a specialized agency

The General Assembly,

<u>Recalling</u> the Lima Declaration and Plan of Action on Industrial Development and Co-operation, adopted at the Second General Conference of the United Nations Industrial Development Organization,  $\underline{1}$ / particularly the decision that the United Nations Industrial Development Organization should be converted into a specialized agency of the United Nations,

Recalling also the framework established by its resolutions 3201 (S-VI) and 3202 (S-VI) of 1 May 1974, containing the Declaration and the Programme of Action on the Establishment of a New International Economic Order, resolution 3281 (XXIX) of 12 December 1974, containing the Charter of Economic Rights and Duties of States and resolution 3362 (S-VII) of 16 September 1975 on development and international economic co-operation,

Recalling further Economic and Social Council resolution 2113 (LXIII) of 4 August 1977 on the convening of the conference of plenipotentiaries on the constitution of the United Nations Industrial Development Organization as a specialized agency,

Noting paragraph 184 of the report of the Industrial Development Board on its

eleventh session, 2/ which refers to the convening of a conference of plenipotentiaries on the establishment of the United Nations Industrial Development Organization as a specialized agency,

Bearing in mind the urgent need for the conversion of the United Nations Industrial Development Organization into a specialized agency,

<u>Recalling</u> in this connexion its resolution 31/161 of 21 December 1976 which, <u>inter alia</u>, called upon the Committee to Draw up a Constitution for the United Nations Industrial Development Organization to accelerate its work so as to enable the conference of plenipotentiaries to meet,

1. <u>Decides</u> to convene at United Nations Headquarters the Conference of Plenipotentiaries on the Establishment of the United Nations Industrial Development Organization as a Specialized Agency for a period of three weeks, beginning 20 February 1978;

2. <u>Requests</u> the Secretary-General to invite:

(a) All States to participate in the Conference;

(b) Representatives of organizations that have received a standing invitation from the General Assembly to participate in the sessions and the work of all international conferences convened under its auspices in the capacity of observers, in accordance with its resolution 3237 (XXIX) of 22 November 1974;

(<u>c</u>) Representatives of the national liberation movements recognized in its region by the Organization of African Unity, in the capacity of observers, in accordance with its resolutions 3280 (XXIX) of 10 December 1974 and 31/152 of 20 December 1976;

(<u>d</u>) The United Nations Council for Namibia to participate in accordance with paragraph 3 of its resolution 32/9 D of 4 November 1977;

(<u>e</u>) The specialized agencies and the International Atomic Energy Agency, the World Tourism Organization, as well as interested organs of the United Nations, to be represented at the Conference;

 $(\underline{f})$  Interested intergovernmental organizations to be represented by observers;

3. <u>Requests</u> the Secretary-General to ensure that the necessary arrangements are made for the effective participation in the Conference of the representatives referred to in paragraphs 2 (b) and (c), above, including the requisite financial provisions for their travel expenses and <u>per diem</u>;

4. <u>Requests</u> the Secretary-General to make the necessary arrangements for holding the Conference at United Nations Headquarters during the period indicated above, to submit to the Conference all relevant documentation and to arrange for the necessary staff, facilities and services that it will require, including the provision of summary records;

5. <u>Decides</u> that the languages of the Conference shall be those used in the General Assembly and its Main Committees.
