Introduction

The 2009 resumed substantive session of the Economic and Social Council was held on 8 October and 15 December 2009. The action taken by the Council at that session is summarized herein.

B. Coordination, programme and other questions

4. Long-term programme of support for Haiti

1. The Council resumed its consideration of agenda item 7 (d) at its 47th meeting, on 15 December 2009. An account of the discussion is contained in the relevant summary record (E/2009/SR.47). For its consideration of item 7 (d), the Council had before it the letter dated 1 October 2009 from the Permanent Representative of El Salvador to the United Nations addressed to the President of the Economic and Social Council (E/2009/117).

Action taken by the Council

2. Under agenda item 7 (d), the Council adopted **decision 2009/267**.

Appointment of an additional member of the Ad Hoc Advisory Group on Haiti

3. At the 47th meeting, on 15 December, the representative of Canada, on behalf of Canada and El Salvador, introduced a draft decision entitled "Appointment of an additional member of the Ad Hoc Advisory Group on Haiti" (E/2009/L.45) (see E/2009/SR.47).

4. At the same meeting, the Council adopted the draft decision. See Council **decision 2009/267**.
