National report on United Nations Security Council resolutions with regard to the Democratic Republic of the Congo

January 2010

Iceland has taken the following measures to implement the provisions of United Nations Security Council resolutions 1493 (2003), 1533 (2004), 1596 (2005), 1649 (2005), 1698 (2006), 1771 (2007), 1807 (2008), 1857 (2008) and 1896 (2009) on sanctions with regard to the Democratic Republic of the Congo.

Legal basis

The legal basis for the implementation of the Security Council sanctions is found in Act No. 93/2008 on the implementation of international sanctions. Regulation No. 119/2009 contains general provisions on the implementation of international sanctions.

Regulation No. 155/2009 implements Security Council sanctions with regard to the Democratic Republic of the Congo.

Arms embargo

Article 2 of regulation 155/2009 prohibits parties in Iceland and Icelandic parties abroad from transferring any military equipment to the Democratic Republic of the Congo in accordance with paragraphs 1-5 of Security Council resolution 1807 (2008) and paragraph 1 of Security Council resolution 1896 (2009).

Travel ban

Article 3 of the same regulation provides for a travel ban on the persons listed in annex I to the regulation in accordance with paragraphs 9-14 of Security Council resolution 1807 (2008) and paragraph 3 of Security Council resolution 1896 (2009).

Assets freeze

Article 4 of the regulation provides for the authorization to freeze funds and financial assets of those listed in annex I to the regulation, in accordance with paragraphs 9-14 of Security Council resolution 1807 (2008) and paragraph 3 of Security Council resolution 1896 (2009).
