## Calendar of conferences and meetings of the United Nations for the biennium 2010-2011

#### Note by the Secretariat

1. The annex to the present note contains the calendar of conferences and meetings of the United Nations for the biennium 2010-2011 as adopted by the General Assembly in paragraph 2 of its resolution 64/230, taking into account other resolutions and decisions adopted by the Assembly at its sixty-fourth session. The annex also includes the calendar of conferences and meetings of the principal organs of the specialized agencies, the International Atomic Energy Agency and treaty bodies established under the auspices of the United Nations for the biennium 2010-2011.

2. In paragraph 5 of its resolution 64/230, the General Assembly noted with satisfaction that the Secretariat had taken into account the arrangements referred to in its previous resolutions, and requested all intergovernmental bodies to observe those decisions when planning their meetings. As requested, the decision to avoid holding meetings on Orthodox Good Friday has been brought to the attention of United Nations bodies whose work programmes include that date. This year Orthodox Good Friday falls on 2 April 2010 (which is an official United Nations holiday) and on 22 April 2011.
