1. **Ms. Osman** (Sudan) introduced draft resolutions A/C.2/64/L.43 and A/C.2/64/L.44 on behalf of the Group of 77 and China.

- 2. **The Chairperson** invited the Committee to take action on draft resolution A/C.2/64/L.23/Rev.1, which had no programme budget implications.
- 3. **Ms. Adam** (Switzerland), introducing draft resolution A/C.2/64/L.23/Rev.1, said that Azerbaijan, Burundi, Canada, Croatia, Dominican Republic, Estonia, Israel and Seychelles had joined the list of sponsors. The word "sensitive" should be inserted in the first line of paragraph 3, before the word "indications".
- 4. Draft resolution A/C.2/64/L.23/Rev.1, as orally revised, was adopted.

5. **The Chairperson** invited the Committee to take action on draft resolution A/C.2/64/L.8/Rev.1, which had no programme budget implications.

- 6. **Mr. Donovan** (United States of America), introducing draft resolution A/C.2/64/L.8/Rev.1, said that Antigua and Barbuda, Argentina, Barbados, Belize, Chile, Croatia, Dominican Republic, Finland, Germany, Greece, India, Italy, Jamaica, Latvia, Lithuania, Mexico, Montenegro, Romania, Singapore, Spain, Sweden and Ukraine had joined the list of sponsors. The beginning of the seventh preambular paragraph should be amended to read "... the Internet Governance Forum as a multi-stakeholder dialogue ...".
- 7. Draft resolution A/C.2/64/L.8/Rev.1, as orally amended, was adopted.

- 8. **The Chairperson** invited the Committee to take action on draft resolution A/C.2/64/L.45 which was being submitted by Mr. Mićić (Serbia), Vice-Chairperson of the Committee, on the basis of informal consultations held on draft resolution A/C.2/64/L.18. The draft resolution had no programme budget implications.
- 9. Draft resolution A/C.2/64/L.45 was adopted.
- 10. Draft resolution A/C.2/64/L.18 was withdrawn.
- 11. **Mr. Igenbayev** (Kazakhstan) said that the draft resolution just adopted once again drew attention to the economic vulnerability of intercontinental States and reaffirmed the priorities of the Almaty Programme of Action, which included trade facilitation for landlocked

developing countries. Adoption of the draft resolution clearly signalled the international community's concern about the high transport costs incurred by such countries. In the past two years, his own Government had made a voluntary contribution of \$150,000 to the United Nations trust fund in support of activities to promote transit transport cooperation. In its capacity as Chair-in-Office of the Organization for Security and Cooperation in Europe (OSCE) in 2010, Kazakhstan would seek to promote the development of Eurasian transport corridors and sustainable, secure transport connections within the OSCE region.

Organization of work

- 12. **Mr. Staur** (Denmark) noted the possibility of an overlap between the dates of the high-level plenary meeting of the General Assembly at its sixty-fifth session and other high-level events scheduled to be held during that session.
- 13. **The Chairperson** called on the facilitators of the related negotiations to consult with one another in an effort to resolve the problem. He announced that the General Committee had decided to recommend to the General Assembly that an additional item entitled "United Nations University" should be included in the agenda of the current session and that it should be allocated to the Second Committee. That new item would be overseen by Mr. Mićić (Serbia), Vice-Chairperson of the Committee.

The meeting rose at 3.55 p.m.
