Latin American and Caribbean States

Adolfo Chávez Beyuma (Plurinational State of Bolivia)

Adolfo Chávez Beyuma began his scholarly education in Tumichuca, Department of Beni, and received his Bachelor's degree from Eduardo Avaroa, a university located in the city of Riberalta. Subsequently, he studied theology in the Instituto Tecnológico Alborada, in the city of Guayaramerín.

After many years away from his hometown, Mr. Chávez Beyuma returned in 1994, after completing his studies. It was there that he began to work actively within the community. Within a relatively short period, he was elected as a juror for the national elections by the Electoral Court Department.

Thereafter, he became a professor at the school of Tumupasa until 1997. In the same year, he served as a pastor in an evangelical church and took his first steps within the Consejo Indígena del Pueblo Tacana (CIPTA), an influential organization within the indigenous movement. Mr. Chávez Beyuma was elected Secretary of Indigenous Land and Territory Central to Indigenous People of La Paz. He served as representative of the indigenous population of Tacana and was re-elected in 1999, serving in that position until 2002.

The following year, and in 2004, he served as mayor under the mandate of the communal assembly in the district of Tumupasa.

Between 2001 and 2003, he served as co-coordinator along with Zulema Lehm in the development of the Strategy for Natural Resources Control Tierra Comunitaria de Origen (TCO) Tacana 2001-2005 (Estrategia de Manejo de Recursos Naturales de la TCO Tacana). With financial support from the Wildlife Conservation Society (WCS)/Bolivia, he led a team of technological professionals who relied on local and communal experts for territorial knowledge and management.

With support from his hometown of Tacana, Mr. Chávez Beyuma was chosen as a representative for the Unidad de Territorialidad Indígena de las Tierras Bajas in 2003.

Beginning in the year 2004, Mr. Chávez Beyuma assisted in the process of territorial management, which led to his being elected by the Consejo Indígena del Pueblo Tacana (CIPTA) as Coordinating Secretary of Non-Timber Natural Resources. He has led the debate and the consolidation of community businesses by governing under the Code of Trade in respect of differentiating among those businesses.

The town of Tacana elected Mr. Chávez Beyuma candidate for the Indigenous People's General Assembly of La Paz (CPILAP), where candidates were elected to represent the Grand Assembly. He served as director of the Confederación de Pueblos Indígenas de Bolivia (CIDOB) for four years. He was then elected as a running candidate for CIDOB by the CPILAP assembly and was elected to the Assembly in August 2006, where he still holds his position.

Alvaro Esteban Pop Ac (Guatemala)

Mr. Pop Ac, a Maya Q'eqchi, is a political analyst. He studied political science and international relations at Rafael Landívar University. For the past 15 years, he has actively advocated for indigenous peoples' rights, in particular drawing the attention of the national and international communities to the situation in the areas of education, human rights, sexuality, health and citizenship.

Founder and current general director of Naleb', a civil society organization specializing in the analysis of the national budget; dialogue and debate on State reform in multicultural societies; the political participation of indigenous peoples; and the contribution of input to legislative efforts in Guatemala (1997-2008).

Head of the Indigenous electoral observation mission, 1999, 2003 and 2007.

Columnist for *Prensa Libre*. Founder and editor-in-chief of the quarterly magazine *Baq'tun*.

Member of the Academic council of the United Nations Educational, Scientific and Cultural Organization (UNESCO) Chair on communication for the strengthening of cultural diversity in Guatemala.

A fundamental tool in this campaign was the interactive exhibition entitled "Why are we the way we are?" (1999-2005).

He coordinated the activities of the National commission of indigenous peoples for constitutional reform. This involved drafting, jointly with the indigenous and general political leadership of Guatemala, a constitutional reform proposal for the consideration and approval of the Congress of the Republic (1997-1998).

He participated in the preparatory process for the Agreement on Identity and Rights of Indigenous Peoples (substantive agreement of the Guatemalan peace agreements) and, later, in the negotiation of the Fiscal Pact (1993-1994).

Dr. Clavero has regularly cooperated, from its very inauguration and as a member of the academic staff, with the Indigenous Fellowship Programme of the Office of the United Nations High Commissioner for Human Rights. In the field of international cooperation, Dr. Clavero has been senior adviser to UNICEF in workshops for the implementation of the UNDAF (United Nations Development Assistance Framework) in Bolivia (January, 2001). In 2007, Professor Clavero was appointed member of the United Nations Permanent Forum on Indigenous Issues for an initial period of three years (2008-2010). During his tenure as a member of the Permanent Forum, Dr. Clavero submitted the following documents to the Permanent Forum: a conference room paper on the significance and unique status of the United Nations Declaration on the Rights of Indigenous Peoples in international human rights law; a report on the mandate stemming from the Declaration for all United Nations agencies, bodies and programmes (co-authored with Carsten Smith); and a report on the "rights of nature" or the "rights of Mother Earth" (co-authored with Carlos Mamani). Dr. Clavero has also participated in various expert and outreach seminars as well as in country visits in his capacity as a member of the Permanent Forum, and contributed to the first major publication on the United Nations Declaration on the Rights of Indigenous Peoples: *Making the Declaration Work: The UN Declaration on the Rights of Indigenous Peoples* (2009).
