# Advisory Committee on Administrative and Budgetary Questions

### Note by the Secretary-General

- 1. As indicated in paragraph 3 of document A/32/101 of 27 May 1977 and in document A/32/101/Add.l of 1 November 1977, it will be necessary for the General Assembly, during the thirty-second session, to appoint six persons to fill vacancies in the membership of the Advisory Committee on Administrative and Budgetary Questions (ACABQ). Five of these vacancies result from the normal expiration on 31 December 1977 of the terms of office of Mr. Yasushi Akashi, Mr. Hou Tung, Mr. André Naudy, Mr. Michael F. H. Stuart and Mr. Morteza Talieh. The sixth vacancy arises from the resignation of Mr. David L. Stottlemyer, as noted by the Secretary-General in document A/32/101/Add.l, effective 15 November 1977.
- 2. Mr. Yasushi Akashi (Japan), Mr. Hou Tung (China), Mr. Michael F. H. Stuart (United Kingdom) and Mr. Morteza Talieh (Iran) have been nominated by their Governments for reappointment. A nomination for the appointment from the Government of France has been received in respect of Mr. Guy Scalabre. The Government of the United States has nominated Mrs. Virginia C. Housholder to fill the unexpired term of Mr. David L. Stottlemyer.

#### MR. MICHAEL F. H. STUART

Mr. Michael Stuart was born in London on 3 October 1926. He won an open demyship in modern history at Magdalen College, Oxford, in January 1945, and after service in the Royal Navy, he read modern history at Oxford from 1947 to 1950, and took his B.A. in 1950 and M.A. in 1952.

In November 1950 he entered the Air Ministry as a general administrator, and served there for 14 years in divisions concerned with organization and supply, personnel administration and financial control. In 1965 he was transferred to the newly created Department of Economic Affairs, where he worked on transport policy, including the investment appraisal of road projects, and the pricing and investment policies of public sector industries. He was promoted to Assistant Secretary in 1969 and transferred to the Treasury to take charge of the division responsible for budgetary control of social security (including the co-ordination of welfare benefits) and of the expenditure of the Lord Chancellor's Department, including the Legal Aid scheme.

In 1974 he was seconded to the Diplomatic Service for service with the United Kingdom Permanent Mission to the United Nations as Treasury Adviser. He was elected a member of the Advisory Committee on Administrative and Budgetary Questions at the twenty-ninth session of the General Assembly in succession to Mr. J. I. M. Rhodes.
