INFORMATION CIRCULAR N° 9

Subject: <u>Revised salary scales for staff in the General Service</u> and Language Teacher Categories

1. The current procedure for effecting interim adjustments of the salary scales for staff in the General Service and related categories at Geneva calls for an adjustment in the net salaries of such staff whenever the consumer price index (CPI) for Geneva moves by 5 per cent by reference to the index used at the time of the previous adjustment or every 12 months, whichever comes first. In order to obtain the amount of the net salary increase, the CPI movement is then adjusted by a factor of 0.9 per cent to account for local taxation. In line with the established practice, 12-month CPI movement is measured two months in advance of the reference date of the salary scale (currently 1 March).

2. In application of the above-mentioned procedure (which is also extended to the Language Teacher category) and based on 12-month CPI movement for the period January 2009 – January 2010, the net salaries of staff in the General Service and Language Teacher categories have been adjusted upwards by 1.05 per cent, with effect from 1 March 2010.

General Service

- 3. The revised salary scales for the General Service category are attached as Annex I.
- 4. The dependency and language allowances remain unchanged.

Language Teachers

- 5. The revised salary scales for the Language Teacher category are reproduced in Annex II.
- 6. The dependency allowances remain unchanged.

Payroll implementation of revised scales

7. The implementation of the revised scales, which are contained in the annexes to the present circular, will be reflected in the April 2010 payroll with retroactive effect to 1 March 2010.
