

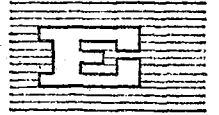

PUBLIC MEETINGS

This corrigendum contains corrections by participants and Secretariat corrections applying to the English text of the summary records of the public meetings of the Commission on Human Rights at its thirty-fifth session (E/CN.4/SR.1477, 1480 - 1500, 1504, 1506, 1508, 1510, 1515/Add.1 and 1516 - 1522). The Commission held 13 closed meetings. The summary records of these meetings (E/CN.4/SR.1501 - 1503, 1505, 1507, 1508/Add.1, 1509, 1510/Add.1 - 1515) were given restricted distribution. The corrections to those summary records appear in document E/CN.4/SR.1477-1522/Corrigendum/Add.1 which has also been given restricted distribution.

With the issuance of the corrigenda E/CN.4/SR.1477-1522/Corrigendum and Add.1 the summary records of the above-mentioned meetings are to be considered final.

2. Somalia pledged its support for the efforts of all peoples to achieve self-determination, and actively supported the particularly heroic struggles of the peoples of southern Africa. Drawing special attention to the struggle for self-determination in Eritrea and Ogaden, he observed that Ethiopia had participated with the European Powers in the colonization of Africa and, now that the latter had granted independence to their colonies, it could not deny self-determination to those areas on grounds of geographical proximity, Africanism or colour. Colonialism had no colour. Ethiopia was engaged in the most inhuman practices in Eritrea and Ogaden in an attempt to dominate the area and violate the human rights of the people living there. The hegemonistic designs of certain countries had contributed to the violation of those rights. Aided and abetted by a super-Power, Ethiopia carried out indiscriminate massacres with the help of the mercenaries of a self-styled non-aligned country, which was nothing but an instrument executing the political will of that super-Power. Cuban mercenaries were engaged in wholesale massacres and destruction in the name of socialism and revolution. Those mercenaries and their allies claimed that they had been invited by a legitimate Government, such a claim was questionable. He wondered who had sanctioned the presence of Cuban mercenaries in Africa and their slaughter of Africans and violation of human rights. Cuba's claim that it defended human rights was an outrage and a blatant exercise in demagogy. The international community must condemn that policy, and demand Cuban withdrawal and the immediate end of the violations of human rights, which threatened the peace of the entire area. No Power could stop a people determined to achieve its self-determination.

Paragraph 3

"Ethiopia engaged in a common struggle against feudalism, imperialism, colonialism and expansionism in a spirit of brotherhood and mutual respect".

In the fifth and seventh sentences, replace the symbol "E/CN.4/L.1465/Rev.1" by the letter "A".

Paragraph 62

In the first sentence, replace the words "part B of that draft resolution" by "draft resolution B".

In the last sentence, replace the words "that draft resolution E/CN.4/L.1465/Rev.1" by "those draft resolutions A and B contained in document E/CN.4/L.1465/Rev.1".

In the masthead, after "SUMMARY RECORD OF THE 1522nd MEETING" add an asterisk. The corresponding footnote should read as follows:

*/ No summary records were made of the 1523rd and 1524th meetings.

In the list of contents, in the last line, replace the agenda item "Organization of work" by "Organization of the work of the session".

Page 9

Between paragraphs 51 and 52, the last symbol of list following sub-heading (b) should read "ST/HR/SER.A/2 and Add.1".

Page 12

The heading preceding paragraph 80 should read "ORGANIZATION OF THE WORK OF THE SESSION".
