Extensions of country programmes Note of the Administrator

Summary

This note contains information on the first one-year extensions of the country programmes for Albania, Bangladesh, Cape Verde, Chad, Ghana, Guyana, Kyrgyzstan, Mauritania, Seychelles, South Africa, Ukraine and Viet Nam and the six-month extension of the country programme for the United Republic of Tanzania; the first two-year extensions of the country programmes for Namibia, Nepal and Sierra Leone; and the second one-year extension of the country programme for Zimbabwe. The requests for second one-year extensions and two-year extensions of country programmes are submitted to the Executive Board for approval.

Elements of a decision

The Executive Board may wish to take note of the first extension of the country programmes for Albania, Bangladesh, Cape Verde, Chad, Ghana, Guyana, Kyrgyzstan, Mauritania, Seychelles, South Africa, Ukraine and Viet Nam for a period of one year, from 1 January 2011 to 31 December 2011, as reported in table 1. The Executive Board may further wish to take note of the six-month extension of the country programme for the United Republic of Tanzania, from 1 January 2011 to 30 June 2011.

The Executive Board may wish to approve the second one-year extension of the country programme for Zimbabwe, from 1 January 2011 to 31 December 2011; and the first two-year extension of the country programmes for Namibia, Nepal and Sierra Leone, from 1 January 2011 to 31 December 2012, as presented in table 2.

This will enable harmonization of the UNDAF cycle 2006-2010 with the Delivering as One cycle 2008-2011.				
Chad	2006-2010	2011			The government of Chad requested an extension of the UNDAF period so that the last year of the UNDAF would coincide with the revised MDG-based national strategy for poverty reduction 2008-2011.

United Republic of Tanzania		2011			The government of the United Republic of Tanzania will be embarking on a new national development framework in July 2011 and has asked the UNCT to align the UNDAF and related country programming instruments to the national planning and budget cycle. This implies a six-month extension of the current country programme and a switch of the country programme cycle from January-December to July-June.
Viet Nam	2006-2010	2011	The government of Viet Nam and its partners agreed to extend the One UN Plan for one year to synchronize the UNDP programming cycle, which is a prerequisite for United Nations reform, and also to draw on the content of the Socio Economic Development Plan 2011-2015, currently being developed.
