## Item 2 Annual report of the Administrator

The annual report of the Administrator on the strategic plan: performance and results for 2009 is submitted in line with Executive Board decision 2009/9, which called for an in-depth analysis of results. The report provides a high-level account of development results across all regions and practices, along with coordination results and management results. The report provides a detailed assessment of results under six selected outcomes in the areas of MDG/poverty, climate change and crisis prevention and recovery, and it explores additional cross-cutting results including in the areas of gender and capacity development. The report includes broad lessons drawn from evaluations in each of the six outcome areas and actions being taken to overcome them. The next report on the strategic plan will be the midterm review, to be presented to the annual session 2011, for which UNDP will propose an approach for Board consideration.

In line with General Assembly resolutions 59/267 and 62/246, the UNDP report on the recommendations of the Joint Inspection Unit (JIU) provides a summary of management responses to the relevant recommendations in the reports issued by the JIU in 2009 and draws attention to specific recommendations intended for use by the UNDP Executive Board. It also notes the implementation status of recommendations contained in the 2008 and 2007 reports of the JIU. The Board may wish to take note of the report.

The statistical annex contains detailed financial information on the annual stock of income and expenditures for UNDP country programme activities and for the funds and trust funds administered by UNDP.

## Item 4 Evaluation

The annual report on evaluation is the fourth report submitted by the Evaluation Office of UNDP to the Executive Board since approval of the UNDP evaluation policy in 2006. The report assesses the progress made by the Evaluation Office and the evaluation units of the associated funds and programmes in fulfiling the function outlined in the policy. It also presents an assessment of the evaluation capacity in the organization, evaluative evidence available for managing development results and compliance in decentralized evaluation. The report discusses lessons emerging from independent evaluations and presents the programme of work for 2010-2011. The Executive Board may wish to take note of the report and adopt a decision, elements of which are contained in the report.

The independent review of the UNDP evaluation policy was requested by the Executive Board in its decision 2006/20. A team of independent consultants assessed the performance of the evaluation function and the extent to which the organization has responded to the policy's requirements and identified lessons and recommendations. Senior advisers guided the independent team throughout the review process and ensured the quality of the process, methodology and the final report. The evaluation will be accompanied by the UNDP management response.

The Executive Board mandated the Evaluation Office to undertake forward-looking evaluations of the UNDP regional programmes to assess their effectiveness prior to the drafting and submission of new regional programme documents. The report provides the findings and conclusions of the independent evaluation of the regional programme for Europe and the Commonwealth of Independent States, 2006-2010. It

also includes recommendations intended to contribute to formulation of the next regional programme and its alignment with the UNDP strategic plan. The evaluation will be accompanied by the UNDP management response.

It also covers the broad range of consultations and other interactions among stakeholders from around the globe, the informal Executive Board consultation process during preparation of the Report and the discussion around the Human Development Index. In addition the update anticipates some broad and emerging findings of the 2010 Report, which will be further elaborated in the oral presentation.

## Item 7 Report of the Ethics Office of UNDP

The second report on the activities of the UNDP Ethics Office is submitted to the Administrator pursuant to the Secretary-General's Bulletin on United Nations system-wide application of ethics: separately administered organs and programmes (ST/SGB/2007/11) and to the Executive Board pursuant to decision 2008/37, paragraph 10. It conforms to the framework adopted by the United Nations Ethics Committee and was reviewed by the Committee at its 19th session, on 22 February 2010. The report covers activities from 1 January to 31 December 2009, during which the Office responded to more than double the number of requests (392) that it had received in the last reporting period.

## Item 8 United Nations Capital Development Fund

The annual report of UNCDF documents and analyses performance against established targets in terms of programme, management and financial results. The annual report is part of the UNCDF results-based management system and reflects its efforts to monitor and improve performance in its two practice areas: local development and inclusive finance. The report also includes management and financial results for 2009. A process of internal reflection begun in late 2008 led to refinement of priorities for the period 2010-2013. These include increasing operational effectiveness, responding to demand from least developed countries for new kinds of support and strengthening strategic partnerships.

## Item 9 United Nations Volunteers

The report on the UNV programme provides an overview of results achieved during the 2008-2009 biennium in the three areas of the its business model – advocacy, integration and mobilization – in support of programme countries and United Nations organizations in their efforts towards peace and development, including achievement of the Millennium Development Goals. The report illustrates organizational results: (a) global recognition of volunteerism for peace and development; (b) integration of volunteerism into peace and development; (b) integration of volunteerism and diversity of volunteers contributing to peace and development. Furthermore, strategic guidance, organizational oversight and accountability of UN Volunteers are captured in a chapter on management results.

## Item 10 United Nations Development Fund for Women

The document reports on the second year of implementation of the UNIFEM strategic plan, 2008-2013, as approved by the Executive Board in its decision 2007/35 and extended in decision 2009/13. The document is submitted in accordance with decision 2004/20. The report tracks progress according to the strategic priorities and results outlined in the UNIFEM frameworks for development results, management results and integrated resources. The report highlights UNIFEM efforts to

fulfil its dual mandate of supporting countries to advance gender equality in line with national priorities and supporting action on gender equality throughout the United Nations development cooperation system. The Executive Board may wish to take note of the report and its results-based focus and recognize the contribution of UNIFEM in supporting programme countries as they advance their development priorities.

## Item 12 Internal audit and oversight

Under this item, the Executive Board will have before it the internal audit and oversight reports of UNDP, UNFPA and UNOPS.

The UNDP report provides information on the activities of the Office of Audit and Investigations for the year ended 31 December 2009, including its implementation of Executive Board decision 2008/37. As requested by the Board in its decision 2009/15, the report contains comprehensive information on disclosure of internal audit reports to Member States and a multi-year comparison of trends in audit issues. As requested by the Board in its decision 2006/13, the report is accompanied by the management response (presented separately). In accordance with the approved oversight policy (DP/2008/16/Rev.1), the annual report of the Audit Advisory Committee is appended to the internal audit and oversight report.

The report on UNFPA internal audit and oversight activities in 2009 responds to decision 2009/15 and earlier decisions of the Executive Board. The report seeks to inform the Board of the most significant risks that could impact the work of the Fund in a development environment marked by change and challenges. As requested

by the Executive Board in decision 2008/37, the annual report of the UNFPA Audit Advisory Committee and the management response thereto are provided as annexes to the report on internal audit and oversight. In addition, a comprehensive management response is made available on the UNFPA Executive Board website.

The Executive Board will also have before it an activity report on UNOPS internal audit and related services for the year ended 31 December 2009, presented by the Internal Audit and Investigations Group. ## Item 14 Annual report of the Executive Director

Under this item, the Executive Board will have before it the annual report of the Executive Director for 2009.

Part I of the annual report focuses on the major initiatives undertaken by UNFPA, the results and progress achieved and the challenges encountered in 2009, the second year of the implementation of the extended strategic plan, 2008-2013. The report's structure and analysis are based on the two central frameworks of the strategic plan, namely, the development results framework (with 13 outcomes) and the management results framework (with nine outputs). UNFPA expenditures under each of the 13 outcomes are provided in the integrated financial resources framework contained in the report. The report includes an update on the UNFPA organizational structure that was approved by the Executive Board in decision 2007/43. The annex to the report contains the 2009 indicator update pertaining to the development results framework of the strategic plan.

Part I, Add.1 of the annual report summarizes the financial situation of UNFPA in 2009 and provides statistical highlights concerning the Fund's finances and programmes in 2009. For purposes of comparison, financial information for 2008 is also included in the report. It should be noted that all figures for the 2009 financial information are provisional.

The Executive Board may wish to adopt a decision on the annual report of the Executive Director. Elements for a decision are contained in the report.

Part II of the annual report of the Executive Director for 2009 is entitled Report on the recommendations of the Joint Inspection Unit in 2009. In accordance with General Assembly resolution 59/267, the report provides a synopsis of UNFPA management responses to key recommendations of the Joint Inspection Unit (JIU) relevant to UNFPA and contained in the reports pertinent to UNFPA issued by the JIU in 2009.
