Status of submission and review of fifth national communications

Note by the secretariat

- 1. This note provides information on the status of submission and review of fifth national communications under the UNFCCC and under its Kyoto Protocol, from Parties included in Annex I to the Convention (Annex I Parties).
- 2. The Conference of the Parties, by its decision 10/CP.13, requested Annex I Parties to submit their fifth national communications (NC5) by 1 January 2010, in accordance with Article 12, paragraphs 1 and 2, of the Convention. Decision 8/CMP.3 requested Annex I Parties that are also Parties to the Kyoto Protocol to include, in their NC5s, the necessary supplementary information required under the guidelines for reporting supplementary information under Article 7, paragraph 2, of the Kyoto Protocol (contained in the annex to decision 15/CMP.1).
- 3. At the time of preparation of this note, and as shown in the table below, the secretariat had received 38 fifth national communications. All national communications received so far have been posted on the UNFCCC website.¹
- 4. In accordance with decisions 2/CP.1, 6/CP.3, 11/CP.4, 33/CP.7 and 4/CP.8 national communications from Annex I Parties are subject to in-depth review. Guidelines for review under Article 8 of the Kyoto Protocol (contained in the annex to decision 22/CMP.1) specify that each national communication of Annex I Parties is subject to a scheduled in-country, in-depth review. This in-depth review encompasses review of the supplementary information under Article 7, paragraph 2, of the Kyoto Protocol and also encompasses review of the supplementary information under Article 7, paragraph 1,

of the Kyoto Protocol on the minimization of adverse impacts in accordance with Article 3, paragraph 14, reported under Article 7, paragraph 1.

- 5. In accordance with the guidelines for review under Article 8 of the Kyoto Protocol, the expert review teams shall make every effort to complete the individual review of national communications within two years of their submission. The secretariat plans to organize 13 in-depth reviews of NC5s in 2010, and the remaining in-depth reviews of NC5s within two years of the submission of the national communication, subject to the availability of resources.
- 6. By the time of preparation of this note, the secretariat had coordinated two in-country reviews of NC5s: United Kingdom of Great Britain and Northern Ireland from 1 to 5 March 2010, and Portugal from 26 April to 1 May 2010. The secretariat is planning to review NC5s of Finland, Switzerland, Czech Republic, Ireland, Denmark and Norway during May–June 2010.
- 7. In addition, during 2006–2009 the secretariat completed the coordination of four centralized reviews (including 37 reports) and three in-country reviews of fourth² national communications from Annex I Parties (which were due to be submitted by 1 January 2006). Review reports of all Parties reviewed have been published on the UNFCCC website.³
