## II. Annotations to the provisional agenda

### 1. Opening of the session

1. The twelfth session of the Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol (AWG-KP) will be opened by the Chair on Tuesday, 1 June 2010, at the Maritim Hotel in Bonn, Germany.

### 2. Organizational matters

(a) Adoption of the agenda

2. The provisional agenda for the session will be presented for adoption.

(b) Organization of the work of the session

3. *Background:* At its eleventh session, the AWG-KP agreed to continue its work in 2010 in accordance with its work programme. It further agreed to focus its work on the scale of emission reductions to be achieved by Annex I Parties in aggregate and the contribution of Annex I Parties, individually or jointly, consistent with Article 4 of the Kyoto Protocol, to the scale of emission reductions to be achieved by Annex I Parties in aggregate; and to continue to work on other issues arising from the implementation of the work programme, with due attention to improving the environmental integrity of the Kyoto Protocol.<sup>1</sup>

4. Also at its eleventh session, the AWG-KP requested its Chair to make proposals on the scheduling of the issues referred to in paragraph 3 above, bearing in mind the focus specified in that paragraph.<sup>2</sup> The Chair of the AWG-KP has prepared a note on the scenario for the twelfth session (FCCC/KP/AWG/2010/5). Delegates are invited to consult this scenario note for further information and proposals on the organization of work.

5. The AWG-KP will meet in an opening plenary on Tuesday, 1 June 2010. The Chair will invite statements on behalf of groups of Parties. Delegations are requested to keep their oral statements as brief as possible and to give a hard copy to the conference officers in advance to facilitate the work of the interpreters. Those wishing to make a written statement available to all delegates should bring copies for distribution.

6. Parties are invited to refer to the overview of the session posted on the UNFCCC website and to consult the Daily Programme, published during the session, for a detailed and up-to-date schedule of the work of the AWG-KP.

7. The SBI, at its twenty-fourth session,<sup>3</sup> recommended that meetings should normally end by 6 p.m. but may, in exceptional circumstances, continue to no later than 9 p.m. This session of the AWG-KP will be organized accordingly.

8. *Action:* The AWG-KP will be invited to consider and agree to the proposal by the Chair on the scheduling of issues and to agree on the organization of work for the session.

(c) Election of officers

9. *Background:* Pursuant to rule 27, paragraph 5, of the draft rules of procedure being applied,<sup>4</sup> the Chair of any subsidiary body other than those established by Articles 9 and 10 of the Convention, shall be elected by that subsidiary body from among the representatives of the Parties present at the session, unless the Conference of the Parties decides otherwise. Rule 27 also provides that each subsidiary body shall elect its own Vice-Chair and Rapporteur and that the officers shall be elected with due regard to the principle of equitable geographical representation and shall not serve more than two consecutive terms of one year.

10. At the eleventh session of the AWG-KP, consultations were undertaken with regional groups on the election of the officers of the AWG-KP. The Chair informed the AWG-KP at the closing plenary, that consultations had not been completed. Further, in accordance with rule 22 of the draft rules of procedure being applied, the current officers of the AWG-KP, Mr. John Ashe (Antigua and Barbuda) as Chair, Mr. Harald Dovland (Norway) as Vice-Chair and Mr. Miroslav Spasojevic (Serbia) as Rapporteur, would remain in office until their successors are elected at the next ordinary session of the AWG-KP.

11. In accordance with practice, consultations on the election of officers will continue to be undertaken under the authority of the President of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP). Parties are invited to recall decision 36/CP.7 and to give active consideration to the nomination of women for elective posts in any body established under the Convention or its Kyoto Protocol.

12. *Action:* Following completion of consultations, the AWG-KP will be invited to elect its Chair, Vice-Chair and Rapporteur.

### **3. Consideration of further commitments for Annex I Parties under the Kyoto Protocol**

13. *Background:* The CMP, by its decision 1/CMP.5, requested the AWG-KP to deliver the results of its work pursuant to decision 1/CMP.1 for adoption by the CMP at its sixth session, and to continue its work drawing on the draft text forwarded as part of its report on its tenth session to the CMP at its fifth session.<sup>5</sup>

14. At its eleventh session, the AWG-KP invited its Chair to prepare documentation to facilitate negotiations on the basis of the annex to the report of the AWG-KP on its tenth session, taking into consideration the work undertaken and decisions adopted by the CMP at its fifth session on the basis of the report of the AWG-KP on its tenth session, for consideration by the AWG-KP at its twelfth session.<sup>6</sup>

15. Also at its eleventh session, in order to make progress in its work on the issues referred to in paragraph 3 above, the AWG-KP requested the secretariat to prepare for consideration by the AWG-KP at its twelfth session:

- (a) A paper compiling pledges for emission reductions and related assumptions provided by the Parties to date and the associated emission reductions;<sup>7</sup>
- (b) A technical paper laying out issues relating to the transformation of pledges for emission reductions into quantified emission limitation and reduction objectives.<sup>8</sup>

16. *Action:* The AWG-KP will be invited to consider the documents referred to in paragraphs 14 and 15 above, and to focus on resolving remaining issues with a view to delivering the results of its work to the CMP at its sixth session.
