INTERNATIONAL COVENANTS ON HUMAN RIGHTS

Bulgaria, Byelorussian Soviet Socialist Republic, German Democratic Republic, Guatemala, Guinea, Irag, Lao People's Democratic Republic, Mongolia, Morocco and Viet Nami revised draft resolution

Need to ensure a healthy environment for the well-being of individuals

The General Assembly,

<u>Recalling</u> that in accordance with the provisions of the Universal Declaration of Human Rights 1/ "everyone has the right to a standard of living adequate for the health and well-being of himself and of his family",

<u>Recognizing</u> the need to promote universal respect for, and observance of, human rights and freedoms in all their aspects,

<u>Considering</u> that a better and healthier environment can help to contribute towards the full enjoyment of human rights by all,

<u>Recalling</u> the Declaration of the United Nations Conference on the Human Environment, <u>2</u>/ adopted on 16 June 1972, which states that "both respects of man's environment, the natural and man-made, are essential to his well-being",

<u>Referring also</u> to the 1987 report of the World Commission on Environment and Development, $\underline{3}$ / which recognizes that the 1972 United Nations Conference on the Human Environment brought together the industrialized and developing countries to tackle the questions related to a healthy and productive environment,

<u>Considering</u> that meeting the aspirations of individuals for a better and healthier environment plays an important role for the full realization of economic and social rights,

1. <u>Recognizes</u> that every individual is entitled to live in an environment adequate for the health and well-being of himself/herself and of his/her family;

2. <u>Calls upon</u> Member States and intergovernmental and non-governmental organizations dealing with environmental questions to endeavour to ensure a better and healthier environment;

3. <u>Invites</u> the Commission on Human Rights, through its Sub-Commission, to consider studying the effects of environmental degradation on the full enjoyment of the right to a standard of living adequate for the health and well-being of individuals and to report on it to the General Assembly through the Economic and Social Council;

4. <u>Decides</u> to consider this question at its forty-sixth session under the item entitled "Alternative approaches and ways and means within the United Nations system for improving the effective enjoyment of human rights and fundamental freedoms".
