

## Summary statement by the Secretary-General on matters of which the Security Council is seized and on the stage reached in their consideration

## Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council and in accordance with the note by the President dated 31 December 2008 (S/2008/847), the Secretary-General is submitting the following summary statement.
