# Recommendation for approval of additional regular resources for approved country programmes

#### Summary

As a result of the application of the modified system for the allocation of regular resources and global regular resources available for programmes in 2010, 2011 and 2012, 47 countries require regular resources beyond the levels originally approved by the Executive Board. The Executive Board is therefore requested to approve the additional regular resources for the 47 countries to allow uninterrupted implementation of the country programmes previously approved.

#### Introduction

- 1. The UNICEF medium-term strategic plan (MTSP) for the period 2006-2009 (E/ICEF/2005/11) was approved by the Executive Board in 2005 (Executive Board decision 2005/18), and extended until the end of 2013 (Executive Board decisions 2008/14 and 2009/5).
- 2. Within the context of the MTSP, the Executive Board approves on an annual basis the planned financial estimates reflecting the latest projections of income and expenditures. The Executive Board approved the planned financial estimates for the period 2009-2012 at its 2009 second regular session (Executive Board decision 2009/21).
- 3. Regular resources planning levels for country programmes are established on the basis of the approved planned financial estimates, and using the modified system

for allocation of regular resources for programmes endorsed by the Executive Board (decisions 1997/18 and 2008/15). The regular resources planning levels are posted on the UNICEF Executive Board website.

- 4. As a result of the application of the modified system for the allocation of regular resources and global regular resources available for programmes, 47 country programmes require regular resources beyond the levels originally approved by the Executive Board. These are:
  - (a) The ongoing country programmes, listed in table 1 below;
- (b) The country programmes whose duration was extended in June 2010 for one or two years, as reflected in Executive Board decision 2010/10, listed in table 2;
- (c) The country programme for the United Republic of Tanzania, whose sixmonth extension, from 1 January 2011 to 30 June 2011, was approved by the Executive Director pursuant to Executive Board decision 2010/9, which decided to consider the common country programme of the United Republic of Tanzania at its first regular and annual sessions of 2011 on an exceptional basis also listed in table 2.

The Executive Board is therefore requested to approve the additional regular resources for the 47 countries to allow uninterrupted implementation of the country programmes previously approved.

- 5. Tables 1 and 2 below set out for each of the 47 programmes:
- (a) The period for which the programme was approved by the Executive Board:
  - (b) The balance of approved regular resources available to the programme;
  - (c) The annual regular resources planning level;
- (d) The amount of additional regular resources for which Executive Board approval is needed to reach, as appropriate, the annual planning level for 2010, 2011 and 2012.

#### **Draft decision**

6. It is recommended that the Executive Board approve the following draft decision:

The Executive Board,

*Takes note* of the six-month extension of the country programme for the United Republic of Tanzania, from 1 January 2011 to 30 June 2011;

*Approves* a total of \$340,230,086 in additional regular resources for the approved programmes, as outlined below.
